

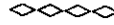

ORDER

Sub:- Adoption of GoR's order dated 12.11.2010 regarding reimbursement of medical attendance and treatment in approved private hospitals for which no reimbursement package has been prescribed.



The Coordination Committee in its 148th meeting held on 16.05.2011 has accorded its approval for adoption of the GoR's Notification No. F.6(5) FD (Rules)/2010 dated 12.11.2010 (copy enclosed) in respect of the captioned subject and decided that the rates so prescribed be made applicable on all the private empanelled hospitals of the Nigam as has been done in cases of GoR's earlier order dated 16.12.2009, 04.02.2010 & 01.06.2010. All the pending cases will be decided in accordance with the provision of this rule.

Therefore, pursuant to the aforesaid decision, the GoR's Notification No. F.6(5) FD (Rules)/2010 dated 12.11.2010 is hereby adopted in the Jodhpur Discom and rate so prescribed in the said order shall be made applicable on all the private empanelled hospitals of the Nigam as has been done in cases of GoR's earlier order dated 16.12.2009, 04.02.2010 & 01.06.2010. All the pending cases will be decided in accordance with the provision of this rule.

**Subject:- Rajasthan Civil Services (Medical Attendance) Rules,2008-
Reimbursement of medical attendance and treatment in
approved Hospitals.**

On the recommendation of the Health Benefit Advisory Committee (HBAC) constituted under Rule 4 of the Rajasthan Civil Services (Medical Attendance) Rules,2008, the State Government has prescribed maximum limit of amount of package for reimbursement of various diseases vide order No. F.6(4)FD/Rules/03 Pt. dated 16.12.2009, 04.02.2010 and 01.06.2010. It has been brought to the notice of the Government that still treatment of a number of diseases has not been covered in the aforesaid orders.

The matter has been considered by the HBAC and it has recommended that in respect of treatment for which no reimbursement package has been prescribed for treatment taken in approved hospitals, reimbursement may be allowed as under :-

1.	Drugs & medicine	100% of the reimbursable drugs & medicine												
2.	Investigations	Rates of Government Hospitals or 70% of the charges paid in the approved hospital as per Rule 6(2)(II)(c)(i) of RCS (MA) Rules, 2008.												
3.	Operation theatre charges	50% of actual expenditure, subject to maximum of Rs 5000/-												
4.	Anesthesia charges	50% of actual expenditure, subject to maximum of Rs 5000/-												
5.	Doctor's fees	50% of actual expenditure, subject to maximum of Rs 6000/-

Accordingly the matter has been considered and the Governor is pleased to order that the reimbursement of Medical attendance and treatment in approved hospitals may be allowed on the basis of aforesaid scales and conditions as recommended by HBAC in cases where limit of package amount for reimbursement of Medical attendance and treatment has not been prescribed in the aforesaid orders dated 16.12.2009, 04.02.2010 and 01.06.2010.

This order shall also be applicable in the case of pensioners/ family pensioners.

This order shall come into force with immediate effect but pending cases shall also be decided in accordance with the provisions of this order.
