ORDER

Sub:- Adoption of GoR's Notification dated 01.06.2002, for appointments and adoption of all the provisions issued from time to time in respect of non-eligibility of candidates, who has more than two children on or after 01.06.2002, in case of promotions.

The Co-ordination Committee in its 149th Meeting held on 15.06.2011 has accorded approval to adopt:

In case of appointment :- the provisions contained in Department of Personnel, GoR Notification No. 7(1) DOP/ A-II/ 95/ Pt-II dated 24.02.2011 in the Nigam, with effect from the date of Government order i.e. 24.02.2011.

In case of promotions: all the provisions issued from time to time by the GoR regarding non-eligibility of candidates who has more than two children and has made it effective in the Nigam prospectively from the DPC's of financial year 2012-13. Accordingly, no person shall be considered for promotion, if he/ she has more than two children on or after 1st April, 2012 (instead of 1st June, 2002 as applicable in case of GoR). The cut off date of 1.6.02, wherever appearing in the GoR provisions be substituted by 1.4.2012 in the JdVVNL rules & regulations.

Accordingly, the Board in its 181st Meeting held on 5th September, 2011 has accorded its approval to make following consequential amendments in the rules related to appointments as well as promotions in the various service regulations of the Nigam:-

(A) For Appointment

The existing regulation No. as mentioned in column no. 3 against each of the following service regulations alongwith amendment (if any), as mentioned in column No. 2 of the table be deleted and a new sub-rule be inserted/ substituted (as the case may be) as mentioned in column no. 4 by the following, namely:-

"No candidate shall be eligible for appointment to the service who has more than two children on or after 01.06.2002.

Provided that the candidate having more than two children shall not be deemed to be disqualified for appointment so long as the number of children he/ she has on 1st June, 2002 does not increase.

Provided further that where a candidate has only one child from earlier delivery but more than one child are born out of a single subsequent delivery, the children so born shall be deemed to be one entity while counting the total number of children.

Provided also that while counting the total number of children of a candidate, the child born from earlier delivery and having disability shall not be counted."

Provided also that the provisions of this sub-rule shall not be applicable to the appointment of a widow to be made under JdVVNL. Compassionate Appointment of Dependents of Deceased Government Servants Rules, 2001."

(B) For Promotion

The existing regulation Nos. as mentioned in column no. 3 against each of the following service regulations as mentioned in column No. 2 of the table be re-numbered and a new sub-rule be inserted as mentioned in column no. 4 by the following, namely:-

"No candidate shall be considered for promotion for five recruitment years from the date on which his promotion becomes due, if he/ she has more than two children on or after 1.4.2012.


Provided that the candidates having more than two children shall not be deemed to be disqualified for promotion so long as the number of children he/ she has on 1.4.2012 does not increase.

Provided further that where a candidate has only one child from earlier delivery but more than one child are born out of a single subsequent delivery, the children so born shall be deemed to be one entity. While counting the total number of children.

Provided also that while counting the total number of children of a candidate, the child born from earlier delivery and having disability shall not be counted."
