ORDER

Pursuant to the decision of the 159th Co-ordination Committee held on 14th Sept., 2012 two notifications issued by the Department of Personnel, Government of Rajasthan, both bearing No. F.5(51) DOP/ A-II/ 88 Pt. dated 25.4.2012, in Rajasthan Compassionate Appointment of Dependents of Deceased Government Servants Rules, 1996 is hereby adopted and accordingly, amendments are hereby made in the JdVVNL Compassionate Appointment of Dependents of Deceased Government Servants Rules, 2001 as under:-

(a) The following sub-clause (ii) of clause (b) of Rule-2 be substituted in place of existing sub-clause (ii) of clause (b) alongwith proviso appearing there under Rule-2 with immediate effect:-

"(ii) holding a post temporarily after appointment on regular basis including period of probation as probationer trainee."

(b) The following amendment be made in sub-rule (1) of Rule-6, with effect from '1.9.2006:-

(i) for the existing expression "pay scale No. 1 to 9A", the expression "Grade pay No. 1 to 10 (Rs. 1300/- to 2800/-)" shall be substituted.


(ii) in proviso, for the existing expression "Pay Scale No. 10 to 11", the expression "Grade Pay No. 11 to 12 (Rs. 3200/- to 3600/-)" shall be substituted.

(c) The following new proviso be added in sub-rule (2) of Rule 6:-

"Provided that in cases where a dependent to whom appointment is offered does not join for any reason whatsoever, another dependent who is otherwise eligible for appointment under these rules may be considered for compassionate appointment, if he applies within ninety days from the date on which the earlier appointment order was received by the appointee.

The above order is subject to ratification by the Board of Directors.
