CIRCULAR

Sub:- Approval to revise/ re-constitute Screening & Reviewing Committee in respect of the cases of compulsory retirement of Nigam's employees who have completed 15 years of service or the date on which he attains the age of 50 years whichever is earlier or on any date thereafter.

In compliance to the decision of the Board of Directors in its 94th Meeting held on 28.03.2006, the "Screening & Reviewing Committee" is hereby constituted for compulsory retirement of employees under Regulation 18 (4) of RSEB Employees Service Regulations, 1964, as under:-

"The Screening & Reviewing Committee in respect of the employees of Jodhpur Discom who have completed 15 years of qualifying service or attained 50 years of age, will be as detailed below, to examine the cases of such employees for premature/ compulsory retirement and make recommendations for implementation by the Appointing Authority:-
