ORDER

Sub:- Relaxation in reimbursement of medical claim to the employees who meets with accident on duty.


Pursuant to the decision of the Co-ordination Committee taken in its 180th meeting held on 08th May, 2015, the immediate medical assistance to an employee for such essential period (life saving period) during which hospitalization in the nearest hospital is done for life saving of employee in case of electrical accidents while on duty will be made in the form of a Short Duration Advance (SDA) upto Rs. 2.00 Lakh, as per existing procedure. SDA over and above Rs. 2.00 Lakh and upto Rs. 5.00 Lakh can be made with approval of CMD/ MD. However, cases beyond Rs. 5.00 Lakh may be put up for consideration of the Board of Directors. Thereafter, medical re-imbusement will be allowed as admissible and adjusted against SDA.

The above new provisions will be made applicable to both type of employees, appointed before 01.01.2004 and covered under Rajasthan Civil Services (Medical Attendance) Rules, 2013 as well as employees appointed on or after 01.01.2004 and covered under Medi claim Policy.

Aforesaid decision will come into force with immediate effect and shall be applicable in case of electrical accidents occurred while on duty on or after 08th May 2015 (date of this Co-ordination Committee Meeting).


This is subject to ratification by the Board of Directors.
