ORDER

Sub:- Relaxation in the prescribed qualification in computer field for clearance of probation training period in the cadre of the ministerial staff who have studied computer subjects for atleast one semester/ year in Graduation/ Post Graduation/ Professional Qualification of any discipline.

Whereas in the 172nd Co-ordination Committee Meeting dated 14th August, 2014, decision was taken to relax the prescribed requirement of qualification in computer field for clearance of probation training period in Engineering and Officers cadre in cases where the candidates have already studied computer subject in their academic curriculum Graduation/ Post Graduation/ Professional Qualification.

Now, the Co-ordination Committee in its 184th Meeting (Item No. 184.8) decided that earlier relaxation given in qualification of computer proficiency vide item No. 172.6 of the 172nd Co-ordination Committee Meeting held on 14th August, 2014 shall be made applicable retrospectively in all cadres from the time when such provisions of qualification of computer proficiency were made applicable in the recruitments.

Accordingly, the earlier relaxation given in the qualification of computer proficiency vide Nigam's order No. 469/ D. 894 dated 20.10.2014 (Admn.- 174) issued as per decision taken by the Co-ordination Committee in its 172nd Meeting held on 14.08.2014 is hereby made applicable retrospectively for all cadres who have studied computer subjects for at least one semester/ year in Graduation/ Post Graduation/ Professional Qualification.

This is subject to ratification by the Board of Directors.
