Pursuant to the approval of the Board of Directors in its 230<sup>th</sup> Meeting held on 23<sup>rd</sup> May, 2016 and in supersession of Nigam's order No. 506/ D. 1531 dated 22.12.2015, the following amendments are hereby made in Jodhpur Discom Service of Engineers (Recruitment, Promotion and Seniority etc.) Regulations, 1969 regarding eligibility criteria for the promotion to the post of Chief Engineer (E&M):

The existing eligibility criteria for promotion to the post of Chief Engineer as appearing in column No. 6 against S. No. 1 in Schedule-I of Jodhpur Discom Service of Engineers (Recruitment, Promotion and Seniority etc.) Regulations, 1969 shall be substituted by the following as under:-

**"Must be working as Additional Chief Engineer (E&M). However, in the event of non-availability of suitable officers for promotion, the officers working in the cadre of Dy. Chief Engineer (E&M), Superintending Engineer (E&M) with three years experience may also be considered for promotion provided he has completed 25 years of service in Engineering Cadre."**

**Note:**

- (i) Aforesaid amendments shall be applicable from the DPC year 2015-16 and onwards.
- (ii) The cut-off date for qualifying experience of 3 years from the date of appointment on the post and total 25 years of service in Engineering

**230.17 :- Amedment in Jodhpur Discom Service of Engineers (Recruitment, Promotion and Seniority etc.) Regulations, 1969 regarding eligibility criteria for the promotion to the post of Chief Engineer (E&M).**

The Board took note of the proposal as contained in the agenda note for effecting amedment in Jodhpur Discom Service of Engineers (Recruitment, Promotion and Seniority etc.) Regulations, 1969 regarding eligibility criteria for the promotion to the post of Chief Engineer (E&M) pursuant to the decision taken in the 186<sup>th</sup> co-ordination committee meeting dated 30.11.2015.

In compliance to the same Office Order No. 506/D. 1531 dated 22.12.2015 was issued by the Company subject to ratification by the Board of Directors. The aforesaid rder was placed beore the 226<sup>th</sup> Board Meeting for ratification where it was directed to be kept in abeyance for further examination.

Subsequently, in the 187<sup>th</sup> co-ordination committee meeting dated 30.12.2015, it was directed interalia as under.

The procedure for calculation of experience etc. shall be at par with the State Government as set out in the Circular No. 91 dated 31.03.2015 issued by the Department of Personnel (KA-2), Government of Rajasthan.

Accordingly, the Office Order No. 506/D. 1531 dated 22.12.2015 requires suitable amendments.

The Board took note of the same and after due deliberation passed the following resolution.

In supersession of Office Order No. 506/D. 1531 dated 22.12.2015, the approval of the Board be and is hereby accorded for effecting Amedment in Jodhpur Discom Service of Engineers (Recruitment, Promotion and Seniority etc.) Regulations, 1969 regarding eligibility criteria for the promotion to the post of Chief Engineer (E&M) as under.

**"Must be working as Additional Chief Engineer (E&M). However, in the event of non-availability of suitable Officers for promotion, the officers working in the cadre of Dy. Chief Engineer (E&M), Superintending Engineer (E&M) with three years experience may also be considered for promotion provided he has completed 25 years of service in Engineering Cadre."**

**Note :**

- i. Aforesaid amendments shall be applicable from the DPC year 2015-16 and onwards.
- ii. The cut-off date for qualifying experience of 3 years from the date of appointment on the post and total 25 years of service in Engineering Cadre shall be 31<sup>st</sup> March of the preceding year to the financial year in which the DPC is to be held.
- iii. The officials promoted to the higher posts against the vacancies existing as on 1<sup>st</sup> April of the year, their experience will be counted from 1<sup>st</sup> of April of the promotion year. The officials promoted against the vacancies occurred after 1<sup>st</sup> of April of the promotion year, their experience will be counted as per the provisions existing hitherto.
- iv. Since the experience criteria has already been reduced, therefore, further relaxation in experience criteria should not be allowed as a matter of routine and it should be allowed only on exceptional circumstances with the permission of the Board of Directors.

- (iii) Since the experience criteria has already been reduced, therefore, further relaxation in experience criteria should not be allowed as a matter of routine and it should be allowed only in exceptional circumstances with the permission of the Board of Directors.


