OFFICE ORDER

Sub. :- Re-imburement of medical claim to the employees who meets with an accident on duty.

Pursuant to the decision taken in the 230th Meeting of the Board of Directors held on 23rd May, 2016, the re-imburement of medical claim is hereby made applicable for all the employees who meets with an accident on duty as decided by the co-ordination committee in the 97th meeting held on 28.09.2006 whether covered under Medical Attendance Rules or Mediciam Insurance Policy (i.e; appointed on or after 1.1.2004).

All expenses incurred during hospitalization including medicine/items not otherwise reimbursable should be allowed for reimbursement when an employee meets with an accident while on duty and has to be rushed to the nearest hospital whether private or Govt. Such relaxation will be provided for such essential period (life saving period) during which hospitalization in the nearest private hospital is unavoidable. As soon as the employee is in a position to be shifted in a Govt. hospital/recognized hospital, it should be done and medical reimbursement be allowed as admissible. The CMD/MD will be authorized to allow reimbursement of non-reimbursable items on case to case basis to the extent considered appropriate and strictly restricting the re-imburement to the category of employees as per their entitlement.

The employees covered under Medical Insurance Policy, the amount of the sum insured from the Insurance Company shall first be exhausted towards the treatment.
