**ORDER**

Sub:- Mediclaim in insurance coverage for the employees appointed w.e.f. 1.1.2004 and for the probation trainee during the period of probation.

The Board of Directors in its 98th meeting held on 24.06.2006, has decided to adopt the G.O.R. Circular No. F.6 (5)(Rules) 2004 dated 27.07.2004 & Notification No. F.6 (6) F.D./ Rules/ 2005 dated 13.03.2006, regarding Mediclaim Insurance Coverage for the employees appointed w.e.f. 01.01.2004 and for the "Probation Trainee" during the period of probation. Accordingly, employees appointed on regular basis w.e.f. 01.01.2004 and probation trainee during the probation period shall be covered for the medical reimbursement under Medical Insurance Policy for "indoor treatment" upto the limit of Rs. 1.00 lac. per annum, excluding employee covered/ governed by ESI Act., 1948, in the Nigam. On the transfer from ESI implemented area to non implemented area, such employee shall be covered by Mediclaim Insurance Policy.
