ORDER

The Board of Directors in its 103 meeting held on 29.09.2006 has decided to make following amendments in JdVVNL Technical Workmen Service Regulations, 1975:-

1. The existing words "Appointing Authority" as appearing in Regulations 4 (B)(i) be substituted by "Authority that may be authorized by the Chairman".
2. In Regulation 4(D)(1) the words "the first day of January next following" be deleted.
3. The existing proviso (i) of Regulation 4(D)(1) be substituted by the following:
 - (i) that the upper age limit mentioned in Schedule-III for-
 - (a) male candidates of SC/ ST/ OBC category shall be relaxed by 5 years;
 - (b) Physically handicapped candidates of General category, OBC category and SC/ ST category shall be relaxed upto 10 years, 13 years and 15 years respectively.
4. Following proviso be inserted as Proviso (iii) below the Regulation 4(D)(1):-
 "That candidates, who have undergone apprenticeship training or rendered service on relevant technical job in any capacity (i.e. Daily Rated/ Work-charges/ Contract Service) in Company shall be given relaxation in upper age limit to the extent of period of such training/ service upto a maximum of 5 years."
5. After the words "Director of Personnel" the words "or any authority, which may be authorized by the CMD" and after the words "eligible candidates" the words "limited to two times vacancies" be inserted in Regulation 4(I)(1).
6. The words "one & half times", as appearing in Regulation 4(I)(3-a) be substituted by "two times".
7. The words "six months" as appearing in para below Reg. 4(I)(3-b) be substituted by "two months".
8. The existing Regulation 4(K)(3) be substituted by the following:
 "No candidate male or female shall be eligible for appointment to the service who has more than two children on or after 01.06.2002. Provided that the candidate having more than two children shall not be deemed to be disqualified for appointment so long as the number of children he/ she has on 01.06.2002, does not exceed.
 Provided further that where a candidate has only one child from earlier delivery, but more than one child are born out of a single subsequent delivery, the children so born shall be deemed to be one entity while counting the total number of children.
 Provided also that the provisions of this sub regulation shall not be applicable to the appointment of a widow to be made under The Rajasthan Compassionate Appointment of Dependents of Deceased Government Servants Rules, 1996, as adopted by the JdVVNL.
 The existing Explanation (ii) appearing below regulation 4(K) shall stand deleted.

10. Following proviso be inserted below Regulation 4(A):

"Provided that in case of candidates standing equal in merit preference shall be given to the candidates having relevant experience in Distribution Sector.

Provided further that on the recommendations of the Selection Committee, the Chairman may allow higher remuneration/ higher start in the prescribed pay scale to such experienced persons."

11. New nomenclature of "Technical Helper" be inserted at Sr. No. 14 under Semi-Skilled category in Schedule-I.

12. In column 2 of Schedule-III "100% by promotion" be substituted against the posts of skilled 'B' and skilled 'A' categories i.e. LM-I, Elect.-I, MTR-I/ I/ II, SBA/ SSA-I, Wireman-I/ II.

13. Existing nomenclature of Foreman-II, Lineman-II, SSA/ SBA-II and Electrician-II be substituted and new nomenclature of Technical Helper be inserted in Schedule-III, as under:
