Retired Executive Engineer	: 10

Retired Assistant Accounts Officer/ Accountant/ Jr. Accountant	: 10

The Board has further resolved that the following fixed remuneration will be allowed to the retired personnel:

Retired Executive Engineer	: Rs. 8000/- per month.
Retired Assistant Engineer	: Rs. 6000/- per month.
Retired Assistant Accounts Officer/ Accountant/ Jr. Accountant	: Rs. 4000/- per month.

It has also been resolved that in addition to the above fixed remuneration, the retired personnel will also get TA & DA as per TA rules of the Company as admissible as per minimum of pay scale of officer/ official in case of attending job out side Head Quarter in the interest of the Nigam.
