
ORDER

Sub:- Relaxation in reimbursement of medical claim to the employee who meets with an accident on duty.

The issue regarding relaxation in reimbursement of medical claim to the employee who meets with an accident on duty has been reconsidered in the 97th meeting of the Coordination Committee held on 28.09.2006, and it was decided that the existing procedure of providing Short Duration Advance (SDA) for medical treatment of an employee meeting with an accident while on duty, to their controlling officer in the name of the employee concerned shall not be changed because a provision of advance as well as rendering of account thereof has to be in the name of beneficiary employee.

Further, all expenses incurred during hospitalization including medicines/ items not otherwise reimbursable should be allowed for reimbursement when an employee meets with an accident while on duty and has to be rushed to the nearest hospital whether private or Government. Such relaxation will be provided for such essential period (Life saving period) during which hospitalization in the nearest private hospital is unavoidable. As soon as the employee is in a position to be shifted in a government hospital/ recognized hospital, it should be done and medical reimbursement allowed as admissible. The Chairman & Managing Director, JdVVNL, Jodhpur is authorized to allow reimbursement of non-reimbursable items on case to case basis to the extent considered appropriate.
