ORDER 47

The Deptt. of Personnel, Govt. of Rajasthan vide Notification dated 13.06.2008 has substituted the existing clause (b) of Rule 2 of Rajasthan Compassionate Appointment of Dependents of Deceased Government Servant Rules, 1996.

The Co-ordination committee in its 126th Meeting held on 29th April, 2009 has accorded approval for adoption of above GoR's Notification dated 13.06.2008 regarding substituting the existing clause (b) of Rule 2 of Rajasthan Compassionate Appointment of Dependents of Deceased Government Servant Rules, 1996.

Accordingly, the existing clause 2 (b) of Rajasthan Compassionate Appointment of Dependents of Deceased Government Servant Rules, 1996 as adopted by Jodhpur Discom be and is hereby substituted as under.

"b" Deceased Government Servant" means a person who was employed in connection with the affairs of the State including a member of All India Services of Rajasthan State Cadre and whose pay was debitible to the consolidated fund of the State and who died while in service and, who was :-

- (i) Permanent, or
- (ii) holding a post temporarily after appointment on regular basis and had put in at least three years continuous service including period of probation as probationer-trainee."

The aforesaid order is subject to the ratification by the Board of Directors.
