### **ORDER**

In light of the recommendations of the Coordination Committee in its 8<sup>th</sup> meeting held on 7<sup>th</sup> November, 2017, it has been decided to substitute the existing sub-regulation (2) of regulation 29-A of the JdVVNL Pension Regulations, 1988 by the following:-


“The amount of ex-gratia grant to the family of a Nigam’s employee who dies in one of the circumstances mentioned in sub-regulation (1) shall be of Rs. 20 lacs. However, if such employee is covered under the ESI Act, 1948 and dies in the circumstances mentioned in (a) of sub-regulation (1), the ex-gratia grant shall be of Rs. 10 lacs.

Provided that no extra relief shall be granted from sundry Government sources to families of deceased employees.

Provided further that if families of deceased employees who are paid compensation/ lump sum amount under the Employees’ Compensation Act, 1923/ ESI Act, 1948 or any other Act or Rules or Regulations, then it should be ensured that the aggregate of the ex-gratia grant/ compensation paid from different sources does not exceed the amount mentioned above (Rs. 10/ 20 lacs, as the case may be) or the amount payable under the statutory provisions of the Employees’ Compensation Act, 1923/ ESI Act, 1948 (excluding the monthly dependent’s benefit) or any other Act, whichever is higher, in each individual case.


This is subject to ratification by the Board of Directors.
