In light of recommendations of the Co-ordination Committee in its 10th meeting held on 14th / 15th March, 2018, it has been decided to adopt the Notifications No. F.7(2) DOP/ A-II/ 84 Pt. dated 06.03.2018 and No. F.1(5) FD/ Rules/ 2016 dated 13.03.2018 issued by the Government of Rajasthan for enhancing the maximum age limit for appointment in various services.

Accordingly, the existing expression "31 years" or "35 years", as the case may be, occurring in the regulation as mentioned in column number 3, against each of the service regulations as mentioned in column number 2 of the following table, shall be substituted by the expression "40 years":-
