ORDER

Sub :- Amendment in Schedule-I & III of Technical Workmen Service Regulation, 1975.

The following amendments are hereby made in the Schedule-I & III of JdVVNL Technical Workmen Service Regulation, 1975, issued vide No. JdVVNL/MD/Secy.(Admn.)/Ju/S.Estt./F. .OO. 786 /D. 1312 dated 12.02.2019 (Admn. 242) namely :-

In Schedule-I

1. After S. No. 5 of item No. 'D', words "Technical Helper" shall be inserted at S. No. 6.

In Schedule-III

1. The words "other than Technical Helper" appearing under "Note" given in column No. 6 against S. No. 2, 3 & 4 shall be deleted.
2. In column No. 6 against S. No. 6, 7 & 8 the words "Technical Helper/" shall be inserted between the words "amongst" and "Helper-I".
3. The word "Seniority" appearing in column No. 7 against S. No. 19, 20, 21 & 22 is hereby deleted.
4. The word and figures "100% by promotion" appearing in column No. 3 against S. No. 23, shall be substituted by the words and figures "100% by direct recruitment".
5. In column No. 6 against S. No. 5, the following "Note" shall be inserted after sub-para (i)-

Note :- "In case of non-availability of sufficient number of Meter Inspector-II eligible for promotion, total 05 years of experience as Meter Inspector-II & MR-II may also be considered."

6. The words "Helper-I" appearing under "Note" given in column No. 6 against S. No. 16 shall be substituted by the words "Technical Helper/Helper-I".

7. In column No. 6, against S. No. 17, the words "Technical Helper/" shall be inserted between the words "amongst" and "Helper-I" in sub para (ii) and the existing entry in sub para (i), shall be substituted as under:-

"80% from amongst Helper-I with secondary or equivalent with 05 years experience and from amongst Technical Helper/Helper-I with ITI/NAC qualification having 3 years experience."

This is subject to ratification by the Board of Directors.

The aforesaid amendments shall come into force w.e.f. DPC year 2019-20
