## **ORDER**

**Sub:- Amendment in the Jodhpur Vidyut Vitran Nigam Limited Engineers' Service Regulations, 2016.**

The Board of Directors of JdVVNL in its 239<sup>th</sup> meeting held on 28.08.2017 has decided to make the following amendments in Schedule I of Jodhpur Vidyut Vitran Nigam Limited Engineers' Service Regulations, 2016 with immediate effect.

1. In Column No. 7 of Item No. 5, Assistant Engineer (E&M/ Civil), the existing remark shall be numbered '1' and the following shall be inserted as a new remarks:-  
"2. The cadre of Feeder Manager is merged with that of Assistant Engineer and Feeder Manager is re-designated as Assistant Engineer (E&M). Feeder Managers appointed in the year 2007 shall be placed in seniority list of AENs (E&M) to be issued for the year 2018-19 as on 01.04.2018 below the Assistant Engineers appointed in 2010-2011 and working as AEN (E&M) on 01.04.2018. Those appointed in the year 2008 shall be placed in the seniority list of AENs (E&M) below the Assistant Engineers appointed in 2011-12 and working as AEN (E&M) on 01.04.2018 to be issued for the year 2018-19 as on 01.04.2018. Feeder Managers shall be counted against the direct recruitment quota of Assistant Engineers and their experience for the purpose of promotion to the post of Executive Engineer shall be counted from 1<sup>st</sup> April, 2011 and 1<sup>st</sup> April, 2012 respectively. Their promotion to Executive Engineer shall be considered on the basis of seniority as on 01.04.2018 only from the year 2018-19."
2. The Item No. 7, Feeder Manager of Schedule I of Jodhpur Vidyut Vitran Nigam Limited Engineers' Service Regulations, 2016 shall be deleted.

This is subject to the outcome of D.B. Civil Writ Petition No. 13772/ 2016 of Hon'ble High Court of Rajasthan, Jodhpur.
