ORDER

Sub: Concessional package to be allowed for revival and sick industries.

In compliance to announcement made during the budget speech for 2004-05 of the State Government in March, 04, a number of concessions were allowed to the sick industries going for rehabilitation/revival. Orders were issued by JdVVNL vide No. Comml.JDP/230 and Comml.JDP/237 in consultation with the Industries Department. In the said order relief (s) announced by the State Government like waiver of interest, penal interest, late payment surcharges, minimum billing during closure period of industry etc. were allowed to the sick industrial units going for revival.

This office is regularly receiving the request from the consumers as well as from the field officers with regard to grant of relief. As per these orders, the name of industry which is included in the list made available by the Industries Department, Government of Rajasthan, Jaipur to the Nigam were allowed relief(s). For industries who were declared sick but whose name(s) were not included in list sent by Industries Department, were also pressing for grant of relief and therefore the matter was referred to the State Government for issuing clarification. It was requested, specifically indicating, if the concession is admissible to sick industries going for revival under orders Comml.JDP/230 and No. Comml.JDP/237 are also admissible to such industries or not, especially in view of the fact the name of the industry has not been included in the list of sick industries. In response to this, the Commissioner (Industries), Rajasthan, Jaipur has clarified as reproduced below:-

“industries which are not part of the list submitted by the Industries Department on 4th December 2004 would also be eligible for the benefits of the aforementioned package on the conditions that they are certified by the Industries Department as sick industry”.

Therefore the benefit of the package in accordance with the Discoms Order No. Comml.JDP/230 dt. 09.08-2004 and Comml.JDP/237 dt. 21.09.2004 would also be available to the industries which are certified by the Industries Department as sick industry.
