ORDER**Sub: Release of Single Point-HT Connection for existing building complexes.**

A voluntary scheme for building complexes have been prescribed by the Nigam vide order Comml.JDP/486 dated 20.03.09 having the following special features:


1. This is purely a voluntary scheme for electrification of building complex.
2. The scheme envisages release of single point HT connection for residential complex(s) and non residential complex(s) i.e. mixed load complex(s).
3. As per above mentioned scheme only one single point HT Connection would be released for the building complex and release of LT connection would be the responsibility of the builder/promoter.
4. For residential complex the tariff schedule DS-HT-1 (Energy Charges @ 300 paisa/unit and Fixed Charges Rs.100/KVA of billing demand per month) would be applicable. For non residential complex energy charges @ 375 paisa/unit and fixed charges @ Rs.80/KVA of billing demand per month i.e. mixed load complex tariff schedule ML/HT-4 would be applicable.
5. HT Metering equipments will be installed by the Nigam at the entrance of the building complex.
6. Individual/occupier of the complex will not approach the Jodhpur Discom for release of new connection for which proper undertaking should be obtained by the builder and submitted to the Nigam.
7. The builders/promoters will be free to release LT connection in the building complex, but in no case the electricity charges more than tariff recovered by the Discoms can be recovered from the consumer on pro-rata basis.
8. The builder/promoter will be free to run stand by DG Sets and charging the consumers accordingly. For such consumption the supplier is required to install separate meter and keep account of the same.

A number of existing building complex had requested for release of single point HT connection for their complex on line with the order of Comml.JDP/486.

The matter was discussed in the meeting of Discom Coordination Forum held on 20th May, 2009 wherein it was decided that the existing building complex having individual LT connection can also apply for release of single point HT connection for their building complex subject to fulfillment of conditions as laid down in the order Comml.JDP/486. The terms and conditions as elaborated in the above order would also applicable for such building complex.

In view of the requirement of initial contract period as per existing provisions the existing building complex who have/will completed/complete 12 months period from the date of connection are/would be eligible to opt for the above scheme of electrification.
