ORDER

Sub.: Procedure for depositing defective meters in store.

The matter of disposal of accumulated meters lying with subdivision was discussed in Sr. Officers meeting held on 03.06.2015 and following revised procedure is hereby prescribed for depositing defective meters in store.

- (i) The meter removed from site will be read through HHT in sub-division (if infrared port/optical port is available) and the reading will be entered in MCO.
- (ii) If the infrared port/optical port is not available and meter could not be read through HHT, then average will be charged for defective/display off period as per rules.
- (iii) If the meter can be read through HHT, but could not be read in subdivision due to non-availability of HHT or due to any other reason, then the meter will be send to meter lab for its reading.
- (iv) List of meters will be prepared by sub-division for GP failed/BGP failed meters separately. Firm wise/TN wise in following format:-

The format will be signed by JEN and ARO of the sub-division and counter signed by AEN. The ARO will certify the last meter reading (taken through HHT) has been entered in binder and in case reading is not possible the average has been charged as per rules.

All defective meters along with list so prepared will be deposited in circle store.

GP failed meters will be delivered by the circle store to respective firm(s) for replacement/repairing.

BGP failed meters will be deposited/ kept in respective circle store(s) for auction thereof.

In case of problem in identification of consumer's detail, a relaxation is granted up to 20th June, 2015 for depositing the meters without consumer's details. For this purpose, a certificate has to be submitted by AEn/JEn/ARO of the sub-division that last meter reading taken through HHT or where reading capturing was not possible either through HHT or through meter lab, has been billed on average basis as per provisions of TCOS-2004. After 20th June,2015 failure to deposition of meters in respective circle on non maintaining the proper account shall be on the part of the concerned subdivisional officer and shall attract disciplinary action against him.
