**Sub: "Amnesty Scheme " for realization of outstanding
Dues from Municipalities, Local Bodies
& Govt. Department.**

With a view to recovery outstanding dues from Local Bodies and Govt. Departments, it has been decided to allow following concessional package. The facility would be available from 15-06-2003 to 15-07-2003 :

Brief description	Concession Allowed
<p><u>Clearance of outstanding dues as on 31-03-2002.</u></p> <p>i) If the total outstanding dues is paid in lumpsum upto 15-07-2003</p> <p>ii) Cases where the consumer is not in a position to deposit the total outstanding dues in lumpsum and CMD has permitted to deposit the outstanding in three equal monthly instalments on merits of the case. However, in such cases also, first instalment should be deposited on or before 15-07-2003 to avail the benefit of scheme.</p>	<p>Entire DPS/LPS/interest accumulated on principal amount of outstanding dues as on 31-03-2002, till date of payment shall be waived.</p>


TERMS AND CONDITIONS:

Note: weekly circle wise report shall be communicated by the concerned Superintending Engineer to the Chief Accounts Officer, Jodhpur Discom, Jodhpur with a copy to the Superintending Engineer(Comml.), Jodhpur Discom, Jodhpur in respect of principal amount recovered DPS/LPS waived and dues to be recovered in instalments. Break up of dues into Nigam's dues and electricity duty may also be intimated separately.

- i) The scheme shall remain available from 15-06-2003 to 15-07-2003.
- ii) The scheme shall be applicable irrespective of whether the disconnected consumer wants reconnection or not.
- iii) To avail these concessions, the consumer shall voluntarily undertake to withdraw all the court cases, if any, pending in any court of law/Consumer Forum/MRTP Commission etc. related to the outstanding dues.
- iv) After depositing the first instalment, if the consumer fails to deposit the balance instalments as per agreed time schedule under this concessional package, this facility shall be withdrawn for the balance outstanding amount.

- v) These concessional package will not be applicable for the amount of assessment made against theft of electricity or malpractice.
- vi) For availing these concessional package, the consumer shall be required to apply on plain paper with the concerned Assistant Engineer.
- vii) The outstanding dues should be worked out without taking into consideration the adjustment of existing security deposit. However, adjustment of security deposit may be made for disconnected consumers on the dues so worked out as on date of disconnection. From such consumers revised security deposit shall be obtained as per rules before reconnection, if any.
- viii) These concessional package shall not be applicable for those consumers who have taken benefit of similar scheme of 1999 or 2000 or 2001 or 2002.
