ORDER

Sub: Release of connections in premises where outstanding dues of previous consumers are lying unliquidated and the assets of the previous consumer are auctioned by State Govt.'s Financial Institutions like RIICO/RFC and also by Official Liquidator appointed by Rajasthan High Court.

Procedure was prescribed for release of new connection and for recovery of outstanding dues of previous consumers in cases where the sick industry is auctioned by State Govt.'s Financial Institutions like RIICO/RFC vide Order No.2179 dt.12-11-2002 (Comml.JDP/145). These instructions were issued in line with the State Govt.'s Order dtd.05-04-2002 copy of which was also enclosed with the above mentioned order. It was prescribed interalia that release of connection in the premises purchased by the auction purchaser as per request of the incoming consumer be processed and connection released as per rules as is done in case of a normal applicant for release of new/permanent connection without insisting for the payment of the outstanding dues of the previous consumer.


Subsequently, the matter was submitted for consideration of the Coordination Committee in its meeting dtd.31-10-2002 with regard to receipt of Nigam's share of outstanding dues out of the sale proceeds of the sick industrial unit. As per the decision of the Coordination Committee, it was clarified vide Comml.-JDP/146 dt.16-11-2002 that the application for new permanent/temporary connection in the premises of sick industrial units auctioned by RIICO/RFC should not be processed till the receipt of Nigam's share of outstanding dues out of the sale proceeds of the industrial unit in terms of Govt. Order dt.05-04-2002.

Subsequently, it was reported that considerable delay was occurring in receipt of Nigam's prorata share of outstanding dues out of the sale proceeds of the auctioned sick industrial unit consequently delaying release of new connection to auction purchaser in the old premises. It was observed that due to time lag in receipt of Nigam's share against the outstanding dues, new connection was getting delayed in a number of cases.

Similar difficulty was reported in cases where the sick industrial unit was auctioned by the Official Liquidator appointed by the Raj. High Court in respect of the BIFR/AIFR cases.

The matter was, therefore, again submitted for the consideration of the Coordination Committee and the committee in its 64th meeting held on 19th Dec., 2003 had decided that application for release of new connection to the auction purchaser in the premises of sick industrial unit acquired/auctioned by RIICO/RFC/Official Liquidator appointed by Raj.High Court, should be processed without waiting for the receipt of prorata share of outstanding dues of the Nigam recoverable from the sale proceeds of the auctioned industrial unit. It was also decided by the Coordination Committee that after recovery of the prorata share of the outstanding dues, cases for waiver of the balance outstanding dues of the previous consumer in individual cases be submitted to the Board of Directors of the Discom for decision in the matter.


In view of these instructions the Nigam's Order Comml.-JDP/146 stands withdrawn.
