**NOTIFICATION**

In exercise of the powers conferred by section 180 read with sub-section (1) of section 127 of the Electricity Act, 2003 (Central Act 36 of 2003), the State Government hereby makes the following rules, namely :-

1. **Short title and commencement** - (1) These rules may be called the Electricity (Appellate Authorities) (Rajasthan) Rules, 2004.
  - 2) They shall come into force from the date of their publication in the Official Gazette.
2. **Definitions** - In these rules, unless the context otherwise, requires :
  - a) "Act" means the Electricity Act, 2003(Central Act No.36 of 2003);
  - b) "Section" means a section of the Act.
3. **Appellate Authority** - An appeal under section 127 shall lie to the officers of the Jaipur Vidyut Vitran Nigam Ltd., Ajmer Vidyut Vitran Nigam Ltd., Jodhpur Vidyut Vitran Nigam Ltd., specified in column (2) of the table below, in their respective jurisdiction in respect of the category of the consumer specified in column (3) thereof -


