**ORDER****Sub: "Amnesty Scheme" for all categories of consumers-  
realization of outstanding dues thereof.**

With a view to recover the outstanding dues from the consumers disconnected up to or before 31-03-07 and running consumers, it has been decided to allow following concessional package for various categories of consumers for a period up to 31<sup>st</sup> May, 2007.

S. N.	Brief Description	Concessions allowed
1.	All categories of consumers except Large Industrial Category (Running as well as disconnected) Clearance of outstanding dues as on 31-03-2007	
(i)	If the consumer deposits the total outstanding dues in lump sum on/or before 31-05-2007	<b><u>For running connections:</u></b> Component of DPS in the outstanding amount as on 31-03-2007 shall be waived off and only principal amount of outstanding as on 31-03-2007 shall be recovered. The principal amount accumulated during 2007-08 shall also be recovered alongwith DPS on full principal amount for the period 01-04-2007 to date of payment.  <b><u>For disconnected connections:</u></b> Component of DPS/interest in the outstanding amount as on 31-03-2007 shall be waived off. The principal amount of outstanding dues as on 31-03-2007 shall be recovered alongwith 6% per annum interest from 01-04-2007 to date of payment.

(ii)	If the consumer is unable to make the payment of outstanding dues in lump sum then he could be given option to deposit dues as given in the next column.	<p><b><u>For running connections</u></b> Component of DPS to the extent of 75% in the outstanding amount as on 31-03-2007 shall be waived off. The payment of principal dues as on 31-03-2007 plus balance 25% DPS plus principal amount of outstanding dues accumulated alongwith DPS on full principal amount for the period 01-04-2007 to date of payment could be made in installments as under :</p> <p>(a) First installment would be 50% of the amount calculated as above and is payable up to 31-05-2007</p> <p>(b) Balance amount is payable in two equal monthly installments. This balance amount shall attract interest @ 10% per annum w.e.f. 01-04-2007.</p> <p><b><u>For disconnected connections:</u></b> Component of DPS to the extent of 75% /interest on outstanding dues on 31-03-2007 be waived off. The payment could be made as under :</p> <p>a) First installment payable before 31-05-2007 shall be 50% of dues as on 31-03-2007 plus interest @ 6% per annum on such dues from 01-04-07 to date of payment.</p> <p>b) Balance dues along with 10% interest w.e.f. 01-04-2007 till date of payment in two equal monthly installments.</p>
2.	<p><b><u>Large Industrial Category Clearance of outstanding dues on 31-03-2007 by industries lying disconnected</u></b></p> <p>(i) If the consumer deposits the total outstanding dues up to 31-05-2007 (Lump sum)</p>	<p>(a) 50% LPS accumulated on dues other than arrears of fuel surcharge, if any, prior to disconnected period shall be waived.</p> <p>(b) No LPS/interest on outstanding arrears of fuel surcharge, if any, shall be charged from date of debiting such fuel surcharge arrear to date of deposit of full amount on or before 31-05-2007.</p> <p>(c) 6% interest per annum on outstanding dues arrived at as per (a) &amp; (b) above as on date of disconnection to date of depositing dues</p>

(ii)	If the consumer is unable to make the payment of outstanding dues in lump sum then he could be given option to deposit dues in installments as given in next column.	<p>(a) 50% LPS prior to disconnected period on arrears other than of fuel surcharge shall be waived.</p> <p>(b) No LPS/Interest on outstanding arrears of fuel surcharge, if any, shall be charged from date of debiting such fuel surcharge arrear to the date of deposit of full amount on or before 31-05-2007.</p> <p>(c) 50% of outstanding dues arrived at as per (a) &amp; (b) above is payable as first installment before 31-05-2007 along with interest @ 6% per annum on outstanding dues from date of disconnection to date of payment of such first installment.</p> <p>(d) Balance 50% amount is recoverable in two equal monthly installments . Interest @ 10% per annum, shall be recovered w.e.f. 01-04-2007 to date of payment of installments.</p>


**Terms & Conditions :**

- (i) The scheme shall be made available for a period up to 31<sup>st</sup> May, 2007.
- (ii) Concerned Assistant Engineer is empowered for allowing rebate in DPS/interest for all categories of consumers and for Large Industrial Category, Chief Engineer (CPM).
- (iii) The scheme shall be applicable irrespective of whether the disconnected consumer wants reconnection or not. Condition of reconnection under Clause 47 (2) of TCOS-2004 is relaxed for Domestic Category of connections only.
- (iv) The scheme will also be applicable to Government Offices, street light connections of Panchayat, Nagar Palika, Nagar Parishad & other street light connections.
- (v) To avail these concessions, the consumer shall voluntarily undertake to withdraw all the Court Cases, if any, pending in any Court of Law/Consumer Forum/MRTP Commission/any other competent agency etc. related to the outstanding dues.
- (vi) If the consumer fails to deposit the amount as per agreed time schedule under this concession package, this facility shall be withdrawn.

- (vii) This concession package will not be applicable for the amount of assessment made against theft of electricity &/or malpractice.
- (viii) This scheme shall not be applicable for consumers who have availed benefits under the Amnesty Schemes announced during the years 2004-05, 2005-06, 2006-07 or 2007-08.
- (ix) For availing the concession package, the consumer shall be required to apply to the concerned Assistant Engineer for all categories of consumers except Large Industrial Category and to the Chief Engineer(CPM) for the Large Industrial Category of consumers in the format enclosed at Annexure-"A".
- (x) The outstanding dues should be worked out without taking into consideration the adjustment of existing security deposit. However, adjustment of security deposit may be made for disconnected consumers in the dues so worked out as on date of disconnection and from such consumers revised security deposit shall be obtained as per rules before reconnection, if any.
- (xi) Since DPS is not separately shown in outstanding dues, the DPS shall have to be segregated from the outstanding dues and shall be waived 100% or 75% as per the scheme. However, where segregation of DPS from the outstanding dues is either not possible or likely to take much time, a rebate shall be allowed in the outstanding dues in lieu of DPS @ 1% or 0.75% per month, as the case may be, i.e. 1% for case, where complete DPS is to be waived and 0.75% for cases where 75% of DPS is to be waived for the months. (reckoning number of month(s) after August, 1997 as levy of DPS was started from August, 1997 only) and the dues are outstanding till date of disconnection (for the cases of connections lying disconnected) or till the consumer makes the payment (for running connection i.e. not lying disconnected).
