**ORDER**

In Pursuance of the provisions under sections 42, 45, 49, 62 and 86 of the Electricity Act, 2003 and the clarification given by the Ministry of Law and Justice in consultation with Ld. Attorney General of India on 13.04.2011, the Ministry of Power, Government of India vide its letter dated 30 Nov. 2011 the following terms and conditions are issued to deal with the Open Access consumers having Demand above 1 MW :-

**I. Consumers drawing energy from Discom exclusively.**  
**(Dedicated Consumers of Discom)**

1. Such consumers shall be levied normal tariff of Discom for their consumption applicable to that category as prescribed by RERC. All rebates such as voltage rebate, power factor rebate/surcharge as applicable shall be allowed/levied to such consumers.
2. For the energy consumed by these consumers during off peak hours i.e. from 11.00 PM to 5.00 AM, a rebate @ 10 % will be allowed.
3. For the energy consumed by these consumers during peak hours i.e. from 6.00 PM to 9.00 PM in winter (November to March) and 7.00 PM to 10.00 PM in summer (April to October), a surcharge @ 20 % will be levied.

**II Consumers who draw energy exclusively from sources other than Discom and draw energy from Discom only in emergency.**

1. Consumers under this category will have to inform at least 48 hrs in advance to the Director (Power Trading)/CE (RDPPC) from the time they intend to start drawing energy from Discom through Fax.



2. These consumers whenever they draw energy from Discom will have to pay temporary tariff i.e. 50 % higher than normal tariff (Fixed charges+ Energy charges).
3. These consumers will have to pay Wheeling charges, cross subsidy surcharge and losses etc. as prescribed by RERC from time to time.
4. However the Discom is not under obligation to supply energy to such consumers.

**III Consumers who purchase energy partially from sources other than Discom except Renewable Energy Sources and partially from Discom -**

1. These consumers shall be levied normal energy charges but the fixed charges would be 1.5 times of tariff of Discom of that category prescribed by RERC. All rebates such as voltage rebate, power factor rebate and surcharge etc. shall be allowed/levied to such consumers.
2. These consumers will have to inform the Director (Power Trading)/CE (RDPPC) along with the schedule 48 Hrs. before the time they intend to draw energy through exchange or otherwise.
3. Once such consumers intend to draw energy as per schedule given, they will have to draw/purchase energy from the sources (other than Discom) for a minimum period of 24 Hrs. i.e. whole day.
4. If such consumer deviates from the schedule given by him and draws energy from Discom against the schedule they would be charged temporary tariff applicable for that category for the energy drawn from the Discom for such deviation of the schedule.
5. Energy drawn from the Discom by these consumers during off peak hours i.e. from 11.00 PM to 5.00 AM, a rebate @ 10 % in the tariff applicable for that category will be allowed.






6. Energy drawn from the Discom by these consumers during peak hours i.e. from 6.00 PM to 9.00 PM in winter (November to March) and 7.00 PM to 10.00 PM in summer (April to October), a surcharge @ 20 % in the tariff applicable for that category will be levied.
7. These consumers will have to pay Wheeling charges, cross subsidy surcharge and losses as prescribed and applicable by RERC.

These conditions would be effective from 4.00 P.M. of 20/01/2012. The consumers are requested to opt for any of the one option out of above three before 4.00 PM of 20/01/2012 and inform to the concerned Assistant Engineer and Circle Superintending Engineer of the respective Discom.
