ORDER

**Sub:- Review of amount of Security Deposit from new consumers
and recovery of enhanced security deposit thereof.**

The regulatory Commission vide their letter Dt. 11-12-2001 has clarified that for new consumers the security initially fixed is provisional in nature and is required to be revised on the basis of actual consumption charges. In such cases, the existing provision for security deposit would continue.

Accordingly the following new paragraph shall be added at the end of item -9 (A) " Security Deposit " for new connections" and above item -9 (B) " For Existing Connections" of Schedule of service & Miscellaneous charge under Part-II, of existing General Conditions of supply :-

"However, for new connections, the security deposit initially recovered as above shall be provisional . The amount of security Deposit shall be reviewed in the beginning of next Financial year on the basis of average monthly consumption of preceding year and difference of the amount equivalent to two month's /One & a half month / One month (as the case may be) consumption charges or minimum billing amount (Whichever is higher,) and the existing amount of security deposit, available in cash with Discom, shall be recovered in cash, from the consumer" .

This order shall come in to force with immediate effect.
