### ORDER

**Sub: “Amnesty Scheme” for disconnected consumers of domestic and agriculture category (disconnected upto or prior to 31.03.2019) for realization of outstanding dues.**

With a view to motivate the disconnected consumers of all categories (disconnected upto or prior to 31.03.2019) to settle their outstanding dues, an amnesty scheme was introduced vide No.1783 dtd.05.12.19 (Comml.JDP/929) which was inforce upto 31.01.2020. This scheme was further extended upto 31.03.2020 vide order No.2175 dtd.31.01.2020 (Comml.JDP/935).

Looking to the situation arisen due to COVID-19, the amnesty scheme for domestic and agriculture category consumer is further extended upto 30.06.2020 with following terms & conditions:

1. This scheme shall be available for the period upto 30.06.2020 for domestic and agriculture category consumers lying disconnected upto and prior to 31.03.2019.
2. The Amnesty Scheme shall not be available to the consumers who have already availed benefit from such schemes in last 3 years.
3. For availing the concession package, the consumer shall require to apply to the concerned Assistant Engineer.
4. One-time payment of principal outstanding amount to be deposited with 100% waiver of LPS/DPS/Interest amount.
5. The disconnected agriculture connections shall be reconnected in accordance with the prevailing provisions of Agriculture Policy. The disconnected connections of domestic category shall be reconnected if feasible irrespective of date of disconnection.

6. The disconnected consumers will be allowed reconnection after depositing the full principal amount and reconnection charges along-with cost of laying any additional line required and payment of security charges separately as per prevailing rules.
7. If a case is pending with any Court of Law and consumer desires to avail benefit of amnesty scheme, he can do so by depositing full principal amount as per scheme & on production of an undertaking to the effect that he will withdraw the court case within a month's time and produce the withdrawal acceptance from the court.
8. In case consumer has dispute with respect to the principal amount & desires to settle first, he may approach to the respective Settlement Forum and after obtaining decision of the Settlement Forum, can avail benefits of Amnesty Scheme, provided he produce an undertaking while approaching the Settlement Forum with regards to acceptance of settlement decision and withdrawal of court case, if any.
