ORDER

Sub: "Amnesty Scheme" for permanently disconnected consumers of all categories (disconnected prior to 31-03-2012) for realization of outstanding dues.

With a view to recover the outstanding dues from the PDC consumers disconnected prior to 31-03-2012, it has been decided by all members of Discom Co-ordination forum to allow concessional package for a period from 16-11-2012 to 31-12-2012, if the consumer deposits the total outstanding dues upto 31-12-2012.


The above concessional package will be applicable for the PDC consumer of categories disconnected upto or before 31-03-2012. Accordingly, if the PDC consumer deposits outstanding amount in one stroke before 31-12-2012, then the applicable interest and DPS/LPS shall be waived off. This scheme/package will be applicable with the terms and conditions as under :

1. The scheme shall be applicable for the period 16-11-2012 to 31-12-2012.
2. One time payments to be taken and no installment is allowed.
3. Under this scheme, the benefit would be given only if the consumer voluntary undertakes to withdraw all the court cases pending in any court of law/consumer forum/any other forum related to the outstanding dues.
4. This scheme will not be applicable for the amount of assessment made against theft of electricity and/or malpractices.
5. This scheme shall be applicable irrespective of whether disconnected consumer wants reconnection or not.
6. The Amnesty scheme shall exclude the consumer already benefited from such scheme in last 3 years.
7. The disconnected agriculture connections shall be reconnected in accordance with the prevailing Agriculture Policy. The disconnected connections of other categories shall be reconnected if feasible as per prevailing Nigam's rules.
8. The disconnected consumers will be allowed reconnection after depositing the full outstanding amount and for reconnection, any additional line is required to be laid, the cost of the same shall be borne by the consumer as per prevailing rules.
9. For availing the concession package, the consumer shall require to apply to the concerned Assistant Engineer for all categories of consumers except large industrial category. In case of LIP, they will have to apply to the Sr. Accounts Officer (HTB) in the format enclosed at Annexure-"A".

10. The outstanding dues should be worked out after adjusting of security deposit if not already adjusted.
