### ORDER

Department of Personnel, Government of Rajasthan vide order No.F.7(2)/Karmik/ K-2/ 15 Part Dated 22.05.2017 has issued direction for implementation of interim order passed by Hon'ble Supreme Court on 09.05.2017 in Civil Appeal No. 1464-1466/2017 - State of Rajasthan & Ors. V/s Captain Gurvinder Singh & Ors..

Accordingly, in continuation to order No.677/1414 dated 01st Febuary-2017, read with order No. 17/21 dated 06th April-2017 following candidate is hereby appointed on the post of "**Assistant Engineer (Electrical)**" as Probationer Trainee:-

Appointment of above one candidate of SBC category is subject to final decision of Hon'ble Supreme Court in Civil Appeal No. 1464-1466/2017 - State of Rajasthan & Ors. V/s Captain Gurvinder Singh & Ors. However, the appointment so made shall not confer any right to them for any appointment on permanent basis in the eventuality of the appeals being dismissed.

Above candidates are advised to report to the Secretary (Admn.), JdVVNL, Jodhpur, on the terms & conditions laid down here under.

## Terms & Conditions-

The Terms & Conditions as per JdVVNL Service Regulations/Orders, the major ones are given below:-

1. Initially these appointment are as "Probationer-Trainee" for a period of two (2) years and during the period of probation training, they shall be paid fixed remuneration @ Rs. 22,180/- (Rupees Twenty two thousand One Hundred eighty only) per month. After successful completion of probation-training period, they will be fixed in the regular pay scale of Assistant Engineer(Electrical) in running Pay Band (PB-3) of Rs.15600-39100 with Grade Pay of Rs. 5400/-. The period of probation-training shall not be counted for grant of annual grade increment(s). However, the period spent as Probationer Trainee shall be counted for experience & eligibility for promotion.

However, the appointment of Shri VIKRAM GURJAR shall not confer any right to him for any appointment on permanent basis in the eventuality of the Civil Appeal No. 1464-1466/2017 - State of Rajasthan & Ors. V/s Captain Gurvinder Singh & Ors. being dismissed. He will not be having any right for confirmation.

Provided that the probationer trainee, if any, who is already in-service of JdVVNL may opt either for fixed remuneration or existing pay and all the admissible allowances he/she is receiving prior to joining as probation trainee Assistant Engineer (Electrical) (not the pay band and grade pay of new appointment), whichever is more beneficial to him/her. In case he/she opts for existing pay band and grade pay, he/she shall also be entitled for annual grade increment during probation training period. In case he/she opts for fixed remuneration, he/she shall be paid only fixed remuneration @ Rs. 22180/- (Rupees Twenty Two Thousand One Hundred eighty Only) per month during the probation training period and the period of probation training shall not be counted for grant of Annual Grade Increment(s) to him/her.

2. During the period of probation training, these probationer trainees shall be entitled only to fixed remuneration as above and shall not be entitled to Special Pay, Dearness Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance, Conveyance Allowance or any other allowance(s) called by whatever name.

In case of in-Service Employee of JdVVNL, if he/she opts for fixed remuneration, he/she shall be entitled only to fixed remuneration as above, and shall not be entitled to Special Pay, Dearness Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance, Conveyance Allowance or any other allowance(s) called by whatever name.

3. Services of above Probationer Trainees can be terminated at any time by giving one month's notice in writing or by giving one month's remuneration in lieu thereof; except in case of misconduct of any description where services could be terminated as per relevant provisions, without giving any kind of notice and such persons would not be entitled to any kind of compensation.
4. At the time of joining duties, the above Probationer Trainees, shall have to execute a "Bond" (Performa enclosed as **Appendix-A**) on Non-judicial stamp paper worth Rs.500/- issued in the name of candidate with the specific purpose of executing Bond in favor of JdVVNL, for giving an undertaking that he/she will not leave his/her training/service or resign or take-up another employment during the period of 'Probation-Training' as well as within one year after completion of Probation-Training, and also during any other training period as well as after completion of such training, within a
