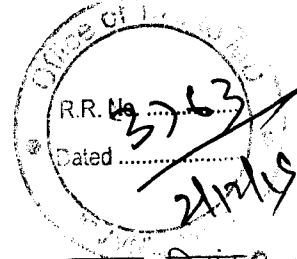

## **Advertisement for Appointment of Chartered Electrical Safety Engineer (CESE)**

### **1. Background:**

The Government of Rajasthan vide notification No.F.23(3)Energy/2015 dated 21-03-2016 has notified 33 kV as the voltage up to which inspection and testing of electrical installation of suppliers or consumers may be carried out by the Chartered Electrical Safety Engineer. The Government of Rajasthan through this advertisement, select and appoint the suitable candidates, possessing necessary qualifications and experience as prescribed in Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010, as Chartered Electrical Safety Engineer (CESE).

### **2. Job Description:**

The Chartered Electrical Safety Engineer (CESE) shall be eligible to perform the inspection of electrical works and electrical installations, as per regulation 30, 32 and 43 of in Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010, of the consumer upto 33 kV anywhere in the State of Rajasthan. The CESE will be approached by the owner of the premises or electrical contractor to carry out the inspection of electrical work and electrical installations. The CESE shall charge an inspection fees as may be prescribed by the State Government from time to time, for this purpose. The services of the CESE will be bound by the Rajasthan Electrical Inspectorate (Formation of Technical Committee and Grant of Licence, Certificate and Permit) Rules, 2016.

### **3. Duties and Responsibilities:**

- a. Receives and schedules inspection requests; communicates with owner of premises and/or contractors regarding scheduling of inspection;
- b. Inspects commercial, industrial and residential electrical installations in compliance with the CEA Regulation (Measures relating to Safety and Electric Supply) Regulations, 2010. Communicates with owner of premises and/or contractors regarding violations of any electrical safety measures as per the said regulations.

- c. Issues written notices of safety measure violations to electrical contractors, installers or owners; ensures the rectification of the same before corrections are made in a timely manner.
- d. Makes periodic inspections of electrical installations and maintenance completed by owner of premises and/or contractors.
- e. Records and maintains accurate records and information regarding inspections and installations; communication with contractors, engineers, architects and owners.

#### **4. Qualification & Experience:**

- a) The applicant should have a degree in Bachelor of Engineering or Bachelor of Technology in Electrical Engineering; and
- b) At least five years of experience in operation and maintenance of electrical installations:

**Note:** (1) The applicant must not possess any electrical contractor' licence or supervisor certificate-cum-permit to work as supervisor or wireman issued by Electrical Inspectorate, Rajasthan. In case the candidate already possesses such licences, certificates or permit, (s)he shall surrender the same before receiving the permit to work as Chartered Electrical Safety Engineer.

(2) Candidature of person employed on full-time basis on regular payroll in Private Sector shall be considered only if accompanied by NoC by competent authority of employer.

#### **5. Submission of Applications:**

The Applicant shall apply in the Application form appended to this notification. - a. Specimen signature and three recent passport size colour photographs with white background showing the complete face of the applicant. The photograph on the application form shall be attested by the Gazetted Officer;

- c. Self-attested copy of certificate as a proof of experience;
- d. Demand draft in support of payment of the fees specified by the State Government for application; and
- e. Self-attested copy of photo identity proof of the applicant issued by the State or Central Government.
- f. Medical certificate of fitness (only in case applicant is above 65 years of age as on 01.01.2019)
