6. Further, while depositing the bid security in the office of the Sr. Accounts Officer (MM&C), Jdhpur, the bidder shall also furnish self-attested documentary evidence duly attested by Notary of SSI unit of Rajasthan or of sick unit (as applicable) and also to submit a letter of quantity offered by them alongwith an Affidavit for MSME unit of Rajasthan in the enclosed format as per Schedule XI is to be furnished on non-judicial stamp paper of Rs.100/- duly attested by Notary public, to the office of Sr. Accounts Officer (MM&C), JdVVNL, Jodhpur. The Bid Security bank guarantee of requisite amount shall be furnished on non-judicial stamp paper of Rajasthan State. Also furnish the undertaking for the CA certificate in the enclosed format as per Annexure-I on non-judicial stamp paper of Rs.100/- duly attested by Notary public alongwith the original / notarised CA certificate as per requirement of tender specifications.
7. The Bank Guarantee against Bid Security be issued by Nationalized / Scheduled Bank. The same may be accepted after confirmation by issuing Bank. If any Bid Security Bank Guarantee not is proper format / not confirmed by the issuing Bank the same would not be accepted and the bidder would be immediately shorted out from bid process.
8. The bidders are required to upload the receipt of depositing all above payments along with their tender at the relevant place on the scheduled date & time otherwise their bids are liable to be rejected.
