The bidders can download bid up to 04:00 p.m. one day prior to schedule date of opening of respective bid mentioned above documents and submit their bids online up to 12:00 p.m. on schedule of respective bid mentioned above.
2. Eligible bidders should submit their bid well in advance instead of waiting till last date JdVVNL will not be responsible for non-submission of bids due to any website related problems.
3. The cost of Tender specification **Rs. 2950/- (For MSME of Rajasthan Rs. 1475/-)**(Non-Refundable) to be paid by Demand Draft in Favour of the Sr. Accounts officer(Cash & CPC), JdVVNL, Jodhpur and tender processing fees Rs. **1000/-** shall be payable by demand draft in favour of The Managing Director RISL, Jaipur ( Non- Refundable). The bidders are required to deposit all these payments in the office of the SE(MM&C), JdVVNL, Jodhpur up to 4.00 PM one day prior to date of tendering otherwise their bids are liable to be rejected.

At the time of depositing the Bid Security amount or Bank Guarantee, the bidder shall also furnish self attested and duly attested by Notary, the documentary evidence of SSI/MSME unit of Rajasthan or of sick unit (as applicable) along with affidavit as per schedule XI on Non-Judicial Stamp of Rs. 100/-.

The Bank Guarantee against Bid Security be issued by Nationalized / Scheduled Bank. The same may be accepted after confirmation by issuing Bank. If any Bid Security Bank Guarantee not is proper format / not confirmed by the issuing Bank the same would not be accepted and the bidder would be immediately shorted out from bid process.



## SECTION-III

**TECHNICAL SPECIFICATION & SCHEDULE OF REQUIREMENT OF SAFETY HELMET MOUNTED WITH ELECTRONIC INDUCTION TESTER AGAINST TN-1709**
**3.01 SCOPE**

This specification covers the manufacturing, requirement regarding material construction, workmanship, finish and performance requirement with testing before dispatch and delivery at our stores anywhere in Jodhpur Discom, of safety helmets to provide protection against head injuries which may be caused by falling objects and other hazards encountered during working on electrical transmission, distribution lines and switchyards.

**3.02 STANDARDS:**

The safety helmets shall be ISI marked and shall meet the requirement of following standards.

- i) IS-2925:1984 (with latest amendments).
- ii) Director General Mines & Safety (DGMS) approved.

**3.03 SCHEDULE OF TECHNICAL SPECIFICATION**
**(A) REQUIREMENT**

The safety helmets shall strictly conform to the requirement of IS:2925/1984 with latest amendments. The helmets shall consist of shell, nape strap and headband having smooth finish, free from burrs and sharp edges. All components used shall have high degree of shock absorption, penetration resistance & shall also have high degree of flammability and electrical resistance. No metal parts shall be used anywhere in the helmet. The helmets shall have peak and ratchet fit. The force transmitted to the head form shall not exceed 5.0 KN.

**(B) MATERIAL**
**(i) SHELL:**

- The material of shell of the helmet shall be conforming to the provisions of IS-2925 and its latest amendments. The material shall not be made up with recycling process. It shall conform to the performance test requirements given in clause 8 of IS. There shall not be any metallic component passing through the shell. The shell shall provide greater toughness thereby offering stronger protection.
- For those parts of the helmet that come in contact with the skin, materials which are likely to cause skin irritation or any adverse effect on health shall not be used.

**(ii) HARNESS:**

The criteria for selection of material for the head band, anti concussion tape etc. shall be sweat resistance, non irritant and shall not cause skin disease.

**(iii) HEADBAND/NAPE STRAP:**

The length of the headband or nape strap shall be adjustable in increments of not more than 5 mm.

**(iv) COMFORT BAND OR SWEAT BAND:**

Forehead comfort band consisting of textile laminated foam sheet shall be provided to have extra softness and comfort to the user. Comfort band shall cover the inner front surface of the headband for a length of not less than 100 mm each side of the centre of the forehead. Further, comfort band shall have a width not less than that of the headband over the length which it covers. The comfort band shall be non skin resistant.

(v) **CHIN STRAP:**

Either helmet shell or the headband shall be fitted with a chin strap.

(C) **SIZE**

Helmets shall be of size suitable for medium sizes as per provisions for IS with replaceable harness.

(D) **CONSTRUCTION:**

The helmets shall be constructed as per provisions of various clauses of IS 2925 /1984 with latest amendments

(E) **Colour:** The helmet shall be of florescent orange/ lime yellow colour.

(F) **Mass:** The mass of the complete helmet without attachments shall not exceed 400 gm.

(G) **Performance Requirements:** The following tests shall be carried out at manufacturer's works to ascertain the performance requirements as per provisions of IS 2925 /1984 with latest amendments.

- i) Shock absorption resistance test :
- ii) Penetration resistance test.
- iii) Flammability resistance test.
- iv) Electrical resistance test.
- v) Water absorption test.
- vi) Heat resistance test.

The manufacturer must have all above test facilities at their works, for this the supplier shall furnish list of testing facilities / equipments available at their works otherwise their offer shall be ignored.

(H) **PACKING AND MARKING**

The helmet shall be suitably packed as per requirement of IS. The safety helmets and harness shall be legibly and indelibly marked by any suitable method not having a harmful effect the following information.

- a) Manufacturer's name or trade mark.
- b) Year and month of manufacturer
- c) TN-1709 and word "JdVVNL".
- d) ISI certification mark.

**3.04 REQUIREMENT FOR ELECTRONIC INDUCTION TETSER**

**3.04.1** Induction tester should be able to sense voltage of LIVE AC lines through remote sensing.

**3.04.2** The dimensions should be less than 9 cms x 2 cms x 1.8 cms (LxBxH).

**3.04.3** Should work on 2x1.5 Volts button type batteries (3VDC) & batteries should be replaceable type.

**3.04.4** The tester should be helmet mountable type.

**3.04.5** Minimum sensing distance for 11 KV line should be 200 cms (2 mtrs.)

**3.04.6** Should be equipped with a buzzer & audio level should not be less than 60 Db when measured from a distance of 2 inches from the tester.

**3.04.7** Should have flexible PVC insulated copper wire as an antenna.

**3.05 SCHEDULE OF REQUIREMENT**

The approximate requirement of safety helmet mounted with Electronic Induction Tester is 5650 Nos.

### **3.06 GUARANTEED TECHNICAL AND OTHER PARTICULARS**

The tenderer shall furnish complete guaranteed and other particulars of material offered by him in GTP.

### **3.07 SAMPLES**

**The bidder shall deposit 1 No. samples of tendered item, along with dimensional drawing indicating all dimensions and weight alongwith Bid to ACOS, JdVVNL, Jodhpur under an intimation to thisoffice i.e. purchaser.**

The sample shall be checked thereafter for visual examination and checking /verification of dimensions, weight etc. as per specification / GTP / Drawing at CTL.

### **3.08 INSPECTION & TESTING**

Inspection & testing shall be carried out at manufacturer's work as per provision of IS 2925/1984 with latest amendments and GTP's of PO.

The supplier should satisfy themselves that the helmets to be supplied are in accordance with the terms of the contract and fully confirm to required specification by carrying out a thorough pre-inspection of each item before tending the same for inspection to the inspecting officer/ inspecting agency nominated by the purchaser. Such pre-inspection on the part of the suppliers would minimize the chances of rejection in inspection.

The material shall be tested and inspected by an authorized inspection officer of the JdVVNL before dispatch. Samples shall be drawn for inspection/testing as per provisions of relevant IS /purchase order. The purchaser reserves the right to get the material tested in any testing laboratory before dispatch.

### **3.09 PRICES:**

The prices are on FIRM basis .The tenderers offered with prices on variable basis are likely to be ignored.

### **3.10 PREFERENCE**

The bidder should be manufacturer/authorized distributor/ sole selling agent / dealer of tendered item. Only ISI marked safety Helmets shall be purchased as such , the bidder should have BIS license of offered item.

### **3.11 DEPARTURE FROM SPECIFICATION**

If the tenderer wish to depart from the specification in any respect, he should clearly state such departures in schedule VI A & VI B indicating the reasons thereof. Unless this is done, the departmental specification will hold good and shall be binding on the supplier.

### **3.12 TENDERS**

Tenderer shall furnish complete particulars of the material offered by them in regard to this specification and submit the same with their tender in single copy. Failure to do so or any incomplete entry therein may prevent a tender from being consideration.

### **3.13 GENERAL**

The tenders received without complete details required as per enclosed forms/schedules are liable to be rejected.

**3.14** As GST act has been effected from 01.07.2017, therefore, BOQ has been prepared accordingly with applicability of GST. Further, old tax structure wherever appearing in ITB/GCC/Specification may be replaced by GST as per notification.

Further, GST registration number of Jodhpur Discom is 08AAACJ8578R1ZJ.

### **3.15 ADDITIONAL ORDER**

Repeat order for additional quantities upto 50% of original ordered quantities, may be placed by the Nigam on the same rates, terms and conditions given in the contract.

**3.16 Quality Assurance Plan:**

- 1) The Bidder shall invariably furnish following information along with his offer, failing which the offer shall be liable for rejection. Information shall be separately given for individual type of equipment offered.
  - i) Statement giving list of important raw material, names of sub-suppliers for the raw materials, list of standards according to which the raw material are tested, list of tests normally carried out on raw material in the presence of Supplier's representative, copies of test certificates.
  - ii) Information and copies of test certificates as in (i) above in respect of bought out items.
  - iii) List of manufacturing facilities available.
  - iv) Level of automation achieved and list of areas where manual processing exists.
  - v) List of areas in manufacturing process, where stage inspections are normally carried out for quality control and details of such tests and inspections.
  - vi) Special features provided in the equipment to make it maintenance free.
  - vii) The bidder should have adequate facilities to carryout accurately all required tests during manufacturing and routine/acceptance tests as per relevant ISS/IEC standards at the final end routine/acceptance. The supplier will ensure that all testing/measuring instruments/apparatus are calibrated at regular periodicity from reputed test house as per relevant standards and a certificate of testing authority is made available to purchaser's inspector at the time of inspection. Such calibration certificates, in any case shall not be older than one year on the date of such tests".
  - viii) List of testing instruments and apparatus along with their last date of calibration, available with the Bidder for testing of equipment specified and test plant limitation, if any, vis-a-vis the type, special, acceptance and routine tests testing during manufacture specified in the relevant standards. These limitations shall be very clearly brought out in "Schedule of Deviations".
- 2) The Supplier shall also submit the following information to the Purchaser, along with drawings/GTPs/BOM of ordered material, within 15 days of placement of order for purchaser's approval:-
  - i) Name of the raw material as well as bought out accessories and the names of sub-suppliers selected from those furnished along with the offer.
  - ii) Type test certificates of the raw material and bought out accessories/items.
  - iii) Quality Assurance Plan (QAP) with hold points for Purchaser's inspection. The QAP and Purchaser's hold points shall be discussed between the Purchaser and the Supplier before the QAP is finalized.
- 3) The Supplier shall submit the routine test certificates of bought out items and raw material at the time of routine testing of the fully assembled equipment.

**3.17 Purchasing on the risk & cost of supplier, in case of non-execution of order/ delay in delivery.**

As per field requirement, as it is, material(s)/ equipment (s) is /are urgently required to Nigam and for which final notice has been given to supplier but supplier is being breach of agreement against stipulated delivery schedule, if at any time during the currency of the contract, the performance in whole or in part be prevented or delayed by more than the three months of the delivery schedule, the purchaser reserves the right to procure the material/equipment on order or part thereof from any other source at the risk and cost of the contractor/ supplier

**3.18** Every Micro, Small & Medium enterprises of Rajasthan shall be required to submit an affidavit in schedule-XI, along with duly filled bid document

**QUALIFICATION REQUIREMENT****ITEM:-Safety Helmet Mounted with Electronic Induction Meter****TN-1709**

The bidder should fulfill following qualifying requirements for successful participation in the tender along with relevant documentary evidence supporting each qualifying requirement without which the offer shall be considered nonresponsive & rejected.

**1.0 STATUS OF BIDDER:-**

a) The bidder should be manufacturer and/ or authorized distributor / sole selling agent/dealer of offered items.

b) Old/ New suppliers:- Any bidder located within or outside the state of Rajasthan has participated for the first time in a particular Discom& meeting minimum qualification requirement and has supplied the tendered material/or of higher rating in other utility shall be treated as an old supplier. Rajasthan's firms although supplied in past but not meeting minimum quantity supplied criterion including altogether new units which have not supplied any quantity but having adequate & required manufacturing and testing facility and technical know-how of the tendered material shall be considered as new firms and would be eligible for trial order only. In case of supply made to the licensed power utility outside India, the C.A. certificate furnished by firm shall be considered.

c) The bidders should be qualified, not be insolvent, not be in receivership, not be bankrupt or being wound up, should not have affairs administered by a court or a judicial officers, should not have business activities suspended, should not be blacklisted or debarred by any utility/ government agency, should not have a conflict of interest. For this bidder is required to furnish a Declaration as per Appendix-B, on Rajasthan Non-Judicial Stamp Paper of Rs. 100/ (excluding surcharge on Stamp Paper, as per rules).

**2.0 PAST SUPPLY & PERFORMANCE CRITERIA:-**

The bidder shall meet both past supply and performance criteria as detailed below for opening of tenders:-

**2.01 PAST SUPPLY:-**

2.01.1 The bidder is required to quote for minimum **10%** of tendered quantity failing which their offer may be considered Non-Responsive.

2.01.2 The bidder should have designed, manufactured / fabricated, tested and supplied to utility / Discoms / Govt. Departments at least 2 X QQ (QQ being the quoted quantity) of similar item / higher rating of tendered material / equipment in last 3 financial years from the date of opening of technical commercial bid.

**Note:** Requirement of quantity manufactured, minimum quantity to be offered and amount of Bank Guarantee to be furnished in absence of test certificate shall be reduced to 25% for Rajasthan based units.

2.01.3 In support of fulfillment of the past supply criteria, the bidder shall furnish documentary evidence in the form of certificate from Chartered Accountant in the enclosed prescribed proforma only. This prescribed proforma should be furnished either in original or copy duly attested by Notary. The bidder shall also sign and affix seal on the C.A. Certificate. The certificate should have membership number with the name & address of the chartered accountant. Certificate should clearly indicate the quantity supplied, period of supply, voltage Class, Rating of the Transformer etc .in the format prescribed, any deviation to format or information diverted format, will not be considered and rejected.

Note:-The material supplied and accepted for same/higher rating for Turnkey projects to a licensed power utility/Govt. shall be considered for the purpose of evaluating criteria. The certificate given by C.A. shall indicate above quantity separately.

**2.02 PERFORMANCE CRITERIA:-**

- 2.02.1 i) If a bidder has supplied up to 50% of ordered quantity in previous tender up to date of opening of subsequent tender and scheduled delivery period expired, the bid of such bidder will not be opened in the Discom for that item.
- ii) However, if the supplies have been completed for a quantity more than 50% but not completed up to date of opening of subsequent tender and scheduled delivery period expired, the quantity equal to the quantity pending in previous tender for that item shall be reduced from the subsequent tender quantity to be allocated to the bidder.

**3.0 POOR RECORD OF PERFORMANCE AND DELIVERY:**

- 1) The bidder who have been black listed in any of the state Discom or with whom business relations have been severed in Jodhpur Discom shall not be considered. Severment of business relations will be done in case of following circumstances for the period and with the recovery mentioned against each:

i) When vendor does not accept order awarded on its accepted price and terms and conditions or does not comply with contractual formalities.	Forfeiture of EMD/cancellation of vendor registration to recover amount of EMD along with severment of business relations for three years from the date of issue of order.
ii) When vendor complies with contractual formalities but does not commence supplies.	Levy of maximum recovery on account of delay in delivery along with severment of relations for a period of 2 years from the date of issue of order or in next two bids whichever is later.

- 2) A Bidder debarred under section 46 of the RTTP Act 2012 shall not be eligible to participate in any procurement process undertaken by-

- (a) any Procuring Entity, if debarred by the State Government; and  
 (b) a Procuring Entity if debarred by such procuring Entity

**4.0 (A) Black listing of a firm:**

After having given Show Cause Notice of 30 days, and having established & cogent reasons for blacklisting of the firm as given below, the firm should immediately be blacklisted for a period of 5 years indicating reasons of doing so, in the letter itself, and a copy of such blacklisting should be given to the firm, with the approval of CLPC:-

(i) There are sufficient and strong reasons to believe that the supplier or his employee has been guilty of malpractices such as manhandling/misbehavior with Government official by supplier or his partner/employee, bribery, corruption or abatement of such a offence in a position where he could corrupt Nigam's official, fraud, vitiating fair tender process including substitution of or interpolation in tender, misrepresentation, pilfer-aging or unauthorized use or disposal of Nigam's material issued for specific work etc.

(ii) Where a supplier or his partner or his representative has been convicted by a court of Law for offences involving moral turpitude in relation to the business dealing or where security considerations including suspected disloyalty to the Nigam/state so warrant the blacklisting.

(iii) If the State Bureau of Investigation or any other authorized investigating agency recommends for blacklisting after completing the investigation.

Note: - 1 If a supplier after having tendered for a supply or after negotiations gives application voluntarily vitiating the fair tendering process, it shall also tantamount to malpractice.

Note: - 2 A register containing the reasons for blacklisting the supplier as also the names of all the partner of the suppliers and the allied concerns coming within the effective influence of the blacklisted supplier will be maintained.

Note: - 3 A register of black listed supplier will be maintained which will not only include suppliers enlisted with the Enlisting Authority but also black listed suppliers in Nigam.

Note :-4 A Black listed supplier (i) shall not be entitled for registration in any of the Discom (ii) shall not be awarded any supply order in future in any Discom during the notified period.(iii) his registration if any shall stand cancelled immediately and his registration security /BG/S.D. shall stand forfeited. (iv) In case of blacklisting of the firm by any one of Discom for the cogent prescribed reason(s) as stipulated above, the same shall be applicable to all the three Discoms and as a

consequence of blacklisting, all the pending orders to that firm, will be cancelled in all three (3) Discoms with immediate effect. However in respect of completed/executed contract G.P. obligations as well as other liabilities shall be fulfilled by the supplier.

**(B) Severment of Business relation:**

(a) After having given Show Cause Notice of 30 days, and having established & cogent reasons for Severment of business relation as given below, the firm should immediately be severed the business relations for a period of 2 to 3 years indicating reasons of doing so, in the letter itself, and a copy of such severment should be given to the firm, with the approval of CLPC:-

(i) The supplier continuously refuses to pay Nigam dues without showing adequate reasons and where the purchasing authority is satisfied that no reasonable dispute attracting reference to Settlement Committee or Court of Law exists for the supplier's action of non-supply.

(ii) When vendor does not accept LOI/detailed purchase order awarded on its accepted prices and terms & conditions or does not comply with the contractual formalities.

(iii) When vendor/supplier who otherwise completed contractual formalities but does not commence supplies on the date of opening of technical bid of the fresh tender/completion of schedule delivery period whichever is later.

**Note-1**-In case supplier does not deposit outstanding dues towards Nigam, even after completion of severment period, the period of severment will continue.

2. Severment done purely/ mainly on account of non-deposition of dues against the supplier/vendor/contractor could be lifted by CLPC, if the dues are deposited prior to the expiry of such severment period.

3. Severment done by one Discom for non-supply of material and /or corresponding non-recovery of dues will not be effective in other Discoms except in respect of common purchase cases of three Discom.

4. On severment of business, the BG/SD/vendor registration security will be forfeited.

5. The orders in execution satisfactorily will not be cancelled other than the order on which severment have been done.

**(C) DEBARMENT**

Reasons on which Debarment can be made:-

(i) The competent authority may debar the supplier on account of his performance or other disabilities, if it is no longer considered fit to remain under vendor registration as per his obligation under vendor registration.

(ii) If at any subsequent stage of inspection of firms after award of contract, it is found that firm does not have sufficient tech. staff or required/necessary technical equipments, the purchasing authority can debar the firm for one year or next tenders whichever is later. Appeal against the order of blacklisting, severment and debarment can be filed before BOD within a period of 3 months from the date of intimation. The letter of appeal will be addressed to the order placing authority. Who will process the case for placing the matter in B.O.D. within a period 60 days. The BOD may reduce or waive the penalty, if sufficient reasons/supporting documents are furnished by the supplier.

ii) The form of appeal shall be as per Rule 83 of RTPP Rules, 2013 and memorandum of appeal shall be filled as per form-1 as prescribed under RTPP Rules, 2013.

Fee for appeal: - Subject to rule 84 of the RTPP Rule 2013 the fee shall be as under:-

a. For First Appeal:- Rs. 2,500/- (Rupees Two Thousand Five Hundred Only)+GST.

b. For Second Appeal:- Rs. 10,000/- (Rupees Ten Thousand Only)+GST.

iii) It is further intimated that the fee shall be paid in the form of Demand Draft of Bankers Cheque of a Scheduled Bank payable in the name of Sr. Accounts Officer (Cash & CPC), JdVVNL, Jodhpur.

iv) Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:

v) Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

vi) The officer to whom an appeal is filed under para (1) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it of within thirty days from the date of the appeal.

vii) If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

8) The bidders should be qualified, not be insolvent, not be in receivership, not be bankrupt or being wound up, should not have affairs administered by a court or a judicial officers, should not have business activities suspended, should not be blacklisted or debarred by any utility/ government agency, should not have a conflict of interest. For this bidder is required to furnish a Declaration as per Appendix-B, on Rajasthan Non-Judicial Stamp Paper of Rs. 100/ (excluding surcharge on Stamp Paper, as per rules).”

9) In case the terms & conditions mentioned in PO, ITB & GCC are modified/differ from RTPP Act, then RTPP Act shall supersede.

**ADDENDUM IN ITB**

**Addendum in the provision of Instruction to Bidder (ITB) in the clause No. 1.12.2 for quantity allocation as per award criteria of purchase manual in accordance to the clause no. 74 of RTPP rules:**

**1.12.2 (A) for quantity allocation**

**(i) Trial order under Para No. 22.17 (a) & (b) of purchase manual**

(a) Any bidder located within or outside the state of Rajasthan has participated for the first time in a particular Discom& meeting minimum qualification requirement and has supplied the tendered material/or of higher rating in other utility shall be treated as an old supplier. Rajasthan's firms although supplied in past but not meeting minimum quantity supplied criterion including altogether new units which have not supplied any quantity but having adequate & required manufacturing and testing facility and technical know-how of the tendered material shall be considered as new firms and would be eligible for trial order only. In case supply made to the licensed power utility outside India, the C.A. certificate furnished by the firm shall be considered.

Note:- The material supplied and accepted for same/higher rating for turnkey project (s) to a licensed power utility/Govt. shall be considered for the purpose of evaluating criteria. The certificate given by C.A. shall indicate above quantity separately.

(b) (i) The trial order for a particular item shall not generally exceed 10% of the total quantity considered for placement of order. This ceiling may, however, be relaxed by the corporate level purchase committee up to the extent of 30% to take the advantage of lower price where situation of differential price offering is arising.

(ii) The capacity & capability assessment of a bidder located outside state of Rajasthan who otherwise qualifies but is participating for the first time shall not be carried out.

Similarly, for the tendered item(s) where the valid BIS license is an essential qualification requirement and the bidder possesses the valid BIS but new to the utility. The capacity/capability assessment of such a bidder shall also not be carried out.

**(ii) Award criteria under Para No. 10.2 (iii) of purchase manual**

(a) In case of distribution transformers of rating 40 KVA and below, LT cables & conductors and fabricated steel items, order quantity may be distributed in the following manner:-

50% to be distributed equally among other firms subject to the condition that not more than 5% of the quantity to be purchased will be allotted to any one of such firms. The balance, if any will be distributed in the same proportion as indicated above among the first four firms.

(b) In case of other items except poles, order quantity may be distributed in the following manner:-

**40% to L1**

**20% to L2**

**10% to L3**

**06% to L4**

The balance quantity may be equally distributed among other firms subject to the condition that not more than 4% of the quantity to be purchased will be allotted to any one of such firm. The balance, if any will be distributed in the same proportion as indicated above among the first four firms.

(c) In case of poles, the order may be awarded on the basis of landed cost (material and transportation taken together). The allocation of quantity location/destination wise may be made among the eligible firms in equal proportion as far as possible.
