ORDER

The Co-ordination Committee in its 11th Meeting held on 20.06.2018 accorded approval for effecting following amendments in Officers' Service Regulations, 2017 issued vide order No. 256/ D. 477 dated 23.07.2018 (Admn.-240):

1. The existing expression "21 years" as appearing against serial No. 4 under column No. 5 of the Schedule-I shall be substituted by the expression 18 years".
2. The existing expression "21 years" as appearing against serial No. 5 under column No. 5 of the Schedule-I shall be substituted by the expression "18 years".

The aforesaid amendments were subject to ratification by the Board of Directors.

The aforesaid orders were put up before the 246th Meeting of Board of Directors held on 10.09.2018 for ratification.

The Board ratified the orders so issued subject to approval of the Finance Department, Govt. of Rajasthan.

Now, the Energy Department, Govt. of Rajasthan vide letter No. F.4(37) Energy/ 2017 dated 29.10.2018 conveyed that the Finance Department vide their letter dated 23.07.2018 has not agreed to the above proposal.


Accordingly, the Officers' Service Regulations, 2017 as approved by the Energy Department vide letter dated 29.10.2018 in which the total experience prescribed for being eligible for promotion to the post of Chief Controller of Accounts and Chief Personnel Officers as 21 years will continue to prevail.
