ORDER

Sub:- Amendment in JdVVNL Officers' Service Regulations, 2017.

As per the decision taken by the Co-ordination Committee in its 25th meeting held on 08.06.2020 and as approved by the Finance Department, Govt. of Raj., Jaipur vide letter No. F.4(37) Energy/ 2017 dated 05.01.2021, following amendments are hereby made in the JdVVNL Officers' Service Regulations, 2017; namely:-

- (1) In the Schedule-I appended to the said Regulations, the existing entries appearing under Column No. 6 against S. No. 20, shall be substituted by the following; namely:-

“Must hold one of the following qualifications:-

- a) CA/ ICWA; or
- b) MBA of minimum two (2) years from a recognized University established by law in India or equivalent with at least 60% marks {It includes 2 years' P.G. Dipoma in business Management declared equivalent to MBA} or
- c) M.Com. of minimum two (2) years from a recognized University established by law in India or equivalent with at least 60% marks alongwith B.Com. with at least 60% marks.

- (2) In the Schedule-I appended to the said Regulations, the existing entries appearing under Column No. 6 against S. No. 21, shall be substituted by the following; namely:-

“Must hold a Graduation Degree from a recognized University established by law in India or equivalent with at least 55% marks, alongwith:-

- a) A Master Degree in Social Work or MBA/ Post Graduate Degree in Personnel Management/ Human Resource Management (or

Development)/ Industrial Relations of minimum two (2) years duration from a recognized University established by law in India or equivalent with at least 55% marks in Master Degree {It includes 2 years' P.G. Diploma in Business Management declared equivalent to MBA.}, or

- b) A Post Graduate Diploma in Labour Laws/ Labour Welfare & Personnel Management/ Human Resource Management (or Development)/ Industrial Relations from a recognized University established by law in India or equivalent with at least 55% marks in Post Graduate Diploma.

Provided that SC/ ST/ PWD candidates and Nigam's in-service employees may be allowed relaxation of 5% marks in above qualifications."

This is subject to ratification by the Board of Directors.
