ORDER

The Co-ordination Committee of Rajasthan State Power Sector Companies, in its 26th Meeting held on 30.12.2020, has recommended as an inter- company coordination issue, to adopt the notification No. F.7(1) DOP/A-II/ 95/ Pt.-II dated 18.08.2020 issued by the Department of Personnel, GoR and to make necessary amendments in various Service Regulations and Guidelines for DPC, 2017; namely:-

- (1) The existing proviso appearing in the regulation as mentioned in column no. 3 against each of the Regulations as mentioned in column no. 2 of the following table, shall be substituted by the following:-

“Provided also that any person who performed remarriage which is not against any law and before such remarriage he is not disqualified for promotion under this sub-rule, he shall not be deemed to be disqualified with effect from 01.04.2012, if any child is born out of single delivery from such remarriage.”
