**ORDER**

The Managing Director, JdVVNL, Jodhpur has decided to adopt the notification No. F.5(18)DOP/ A II/ 84 pt.IV Jaipur, dated 01.08.2021 issued by the Department of Personnel, GoR.

Accordingly, following amendments are hereby made in the JdVVNL Services (Absorption of Ex-servicemen) Regulations, 2017; namely:-

1. **Amendment of regulation 2** – After the existing sub – regulation (4) of regulation, the following entries shall be added as new sub-regulation 5:-:-

“(5) Reservation to ex-servicemen will be admissible to only those who have settled in the State.”

2. **Amendment of regulation 3** – In clause (a) of regulation 3:

- (i) for the existing expression “person who”, the expression “person settled in the State and who” shall be substituted; and
- (ii) after the existing sub-clause (v), the following Explanation shall be added; namely:

**‘Explanation : The expression ‘person settled in the State’ shall mean ‘the person who is bonafide resident of the State.’ ”**

This amendment shall be deemed to have come into force with effect from 01.07.2021.
