### QUALIFYING REQUIREMENT

#### 1.0 NIT No. 20 (18-19) (Opr.)

1.1 The participating bidders should have GST registration, ESIC registration, PF registration, PAN Card, and Labour license if required.

**OR**

In case of any registration presently not available with the participating firm/bidder then they are required to furnish an undertaking on Rs. 100/- Non judicial stamp paper duly attested by notary public

that the required registration shall be obtained by them and furnished to RVUN within 15 days after issuing the LOI.

1.2 The bidders shall furnish the financial capability of Rs 05 (Five lacs) or above.

**2.0 NIT No. 21 (18-19) (Elect.)**

2.1 The participating bidders should have GST registration with Central Excise Department, PF registration, PAN Card, ESIC registration, and Labour license (if required).

**OR**

In case of ESI registration presently not available with the participating firm/bidder then they are required to furnish an undertaking on Rs. 100/- Non judicial stamp paper duly attested by notary public that the ESI registration shall be obtained by them and furnished to RVUN within 30 days after issuing the LOI.

2.2 The bidders shall furnish the financial capability of Rs 05 (Five lacs) or above.

2.3 The bidders should have at least 1 years experience of similar nature of work during last 5 years in any power station of similar or higher capacity / any other Govt./ Public Sector/ Industrial Organization.

**3.0 NIT NO. 23 (18-19) (Mech.)**

3.1 The participating bidders should have GST registration, PF registration, PAN card, ESI registration, and labour license (if required).

3.2 The bidders shall furnish the financial capability or solvency certificate / document of minimum Rs. 10 (Ten) Lacs or above.

3.3 The contractor should have similar nature of work in any industries/ Utilitis / organizations.

3.4 The bidder should provide satisfactory work completion certificate duly signed by officer not below the rank of superintending engineer or order placing authority of concerned organization.

**4.0 NIT NO. 24 (18-19) (Proc.)**

4.1 The bidders should have experience of similar nature of supply in any power station/ any other Govt./ Public Sector/Reputed Industries and shall have to furnish copies of atleast one or two PO executed during last five years in support of experience. The bidders should ensure supply material of standard Make as in NIT or as suitable for site.

4.2 Bidder should have valid PAN, GST Registration No. and supporting documents must be furnished along with the bid.

4.3 The average annual financial turnover of the bidder during preceding financial years should be minimum Rs.20 lacs. The bidder shall have to provide certified copies of audited latest balance sheet/ solvency certificate that should not be older than 6 months.

4.4 The bidder must ensure that their offer is as per technical specifications given and compatible for the system. The bidder must mention the MAKE of NIT items.

**5.0 NIT No. 25 (18-19) (Proc.)**

5.1 The bidders should have experience of similar nature of supply in any power station/ any other Govt./ Public Sector/Reputed Industries and shall have to furnish copies of at least one or two PO executed during last five years in support of experience. The bidders should ensure supply material of standard Make as in NIT or as suitable for site.

5.2 Bidder should have valid PAN, GST Registration No. and supporting documents must be furnished along with the bid.

5.3 The average annual financial turnover of the bidder during preceding three financial years should be minimum Rs. 15 lacs. The bidder shall have to provide certified copies of latest audited balance sheet for these years or or recent solvency certificate (not older then 6 months).

2.4 The bidder must ensure that their offer is as per technical specifications given and compatible for the system. The bidder must mention the MAKE of NIT items.

**6.0 NIT NO. 27 (18-19) (Opr.)**

6.1 The participating bidders should have GST registration with Central Excise Department, PF registration, PAN Card, ESIC registration, and Labour license (if required).

6.2 The bidders shall furnish the financial capability of Rs 05 (Five) lacs or above.

6.3 The bidder must have an experience of having successfully executed/ completed the contract for operation/maintenance of fire fighting system of high rise building comprising of hydrant system, sprinkler system, fire alarm system and various types of extinguishers works in any of the thermal plant (s)/ gas power plant (s)/ any process indurtries/ any electrical utility/ organization (as the case may according to the nature of work ) during last 7 years ending last day of the month previous to bid opening date with either of the following executed value(s) of the contract(s):-

A. Three executed/ completed contracts as above costing not less than amount equal to 40% of the estimated cost each

**Or**

B. Two executed / completed contracts, as above, costing not less than amount equal to 50% of the estimated cost each.

**Or**

C. One executed/completed contract, as above is costing not less than amount equal to 80%of the estimated cost.

6.4 Satisfactory performance certificate or satisfactory work completion certificate for above executed work should be signed by officer not below the rank of Superintending Engineer or order placing authority of concerned organization..
