
Sub:- Online Transfer Applications.

The Department of Administrative Reforms & Coordination, GoR has lifted ban on transfer of employees vide order dated 6th July, 2021. It has been made mandatory that online applications containing transfer request of employees should be obtained through website/ portal of the department. Neither anyone should submit transfer application in person nor it should be submitted on paper.

Accordingly, it has been decided to invite online applications through "RVUN Intranet" from employees willing for their transfer as per the "Modified Transfer Policy" introduced vide order No.RVUN/P&A/F.BoD/D.325 dated 21.09.2015. Online Transfer applications can be submitted as follows :-

- (i) Officers/officials (excluding Technical workers & Class-IV employees) willing for transfer are required to apply through "Online Transfer Application" procedure only.
- (ii) Link for filling-up details for "Online Transfer Application" will be available to employees from **12th July, 2021** on RVUN Intranet (rrvunl.in) through login from their registered mobile number, which will be accessible by an OTP.
- (iii) In case of any technical problem, employee can intimate through email ID at admin@rrvun.com with full details viz name, designation, station, registered mobile number, etc.
- (iv) **No transfer request, earlier received/pending will be considered.** Besides, any transfer application received through offline mode or in person will not be entertained as per the above referred order of GoR.
- (v) This procedure of filling up 'Online Transfer Application' through RVUN's Intranet will remain operative from **12th July, 2021 to 23rd July, 2021.**
