GENERAL CONDITIONS

1. Purchase of tender specification (non transferable) is essential for participation in bid and can be had from the office of the undersigned (Ramgarh) on any working day from 11.00 AM to 4.00 PM and upto 1.00 PM on previous day of date of opening by remitting the tender cost (non refundable) as above either by cash or DD payable at Jaisalmer in favour of Sr. Accounts Officer, RGTPP, RVUNL, Ramgarh. The tenderer shall make request for each tender separately.
2. The tender documents can also be downloaded from the site www.sppp.rajasthan.gov.in . DD of tender cost shall be attached separately with the filled tender documents.
3. In support of tender's qualifying requirement, the tenderer must enclose the copies of purchase / work order secured for supply / work of similar type of items from other thermal power stations/ Govt. department and proven experience.
4. Bid shall be furnished in two parts in separate envelope. Part 'A' shall contain Technical and commercial details while Part 'B' shall contain only price bid and these shall be enclosed together in single envelope.
5. Tender documents will be issued only to prima facie qualifying parties after scrutiny of documents furnished by in tending tenders along with their request for issue of tender documents. However such issue of tender document will not automatically construe that bidder are considered qualified. Such qualification will be reviewed at the time of evaluation of bids.
6. The tenders shall be accepted up to 4.00 PM on the previous day of date of opening in the office of the undersigned (Jaisalmer OR Ramgarh) and these shall be opened at 3.30 PM (Ramgarh Office) on the date of opening as indicated above in presence of tenderers or their representatives who may like to be present. If the date of tender opening happened to be a holiday, the tenders will be accepted / opened on next working day.
7. Tender without earnest money & details super scribed on the envelope or accompanied inadequate amount shall not entertain and in such cases tenders shall not be opened. EMD in form of DD/ Banker's Cheque in favour of Sr. Accounts officer (RGTPP), RVUNL, Ramgarh payable at Jaisalmer shall be furnished in separate envelope along with tender.
