Requisite tender cost, EMD and processing fees should reach on or before schedule date and time at the office of the Executive Engineer (Proc. & contract), Opposite new Power House, Indira Colony, Barmer. Without Requisite tender cost, EMD and processing fees tender will not open.

Tender TN-478 shall be in single part, both technical bid & finance bid (price bid) shall be open on same day ,tender can be downloaded from www.sppp.rajasthan.gov.in or can be purchase from Office of SE(proc.) by depositing tender fee with application .This tender(TN-478) will accepted off line , received on schedule date and time with EMD & tender fee.

PQR for TN-476(CE) & TN-478

1. Average Annual Financial Turn Over in the preceding three completed financial years as on date of bid opening should not be less equal to three amount calculated on prorata basis for 12 months of the total estimated value of the work or be at-least 30% of the total estimated value of the work, whichever is higher.
2. The bidder must have an experience of having successfully executed / completed the annual contract for similar nature works in any of the thermal power plant(s) / gas power plant(s)/ any process industries/any electrical utility/organization(Govt./reputed) during last 7 years ending last day of the month previous to bid opening date with either of the following executed value(s) of the contract(s):
 - a. Three executed/completed contracts, as above, costing not less than the amount equal to 40% of the estimated cost each
or
 - b. Two executed/completed contracts , as above, costing not less than the amount equal to 50% of the estimated cost each
or
 - c. One executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.
3. Satisfactory performance certificate or its proof for above executed works should be signed by officer not below the rank of Superintending Engineer or order placing authority of concerned organization.

4. The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour license (if required) and class A electrical license (if required).

PQR for TN-477(Civil)

1. Bidder should have solvency more than of the estimated cost. Solvency certificate should not be more than one year old

Or

Average Annual Financial Turn Over during last three year, ending 31st march of previous year, should be at least 30% of the estimated cost.

2. The bidder must have an experience of having successfully completed the annual contract for similar works during last 7 years ending last day of the month previous to the one which application are invited should be either of the following.

- a. Three similar executed/completed contracts, as above, costing not less than the amount equal to 40% of the estimated cost each

or

- b. Two similar executed/completed contracts, as above, costing not less than the amount equal to 50% of the estimated cost each

or

- c. One similar executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.

3. The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour license (if required) and class a electrical license (if required).

Note: - 1.The technical evaluation of the bids shall be done on the basis of above criterions. The offers of the bidder not fulfilling above conditions fully or partially are likely to be ignored& rejected.
