Online tenders are invited by Superintending Engineer (TD-III), Rajasthan Rajya Vidyut Utpadan Nigam Limited, Room No. 308, 3<sup>rd</sup> Floor, Vidyut Viniyamak Bhawan, Sahakar Marg, Jaipur-302005 for **"Annual contract for the Work of complete operation, maintenance and housekeeping of coal handling plant at CSCTPP, Chhabra, including wagon unloading, operation & maintenance of heavy machineries and other equipments, Electrical & C&I works, of CHP area and other related works as specified in the scope of work for 2x660 MW, Unit-5&6 of Chhabra Super Critical Thermal Power Project (CSCTPP), Chhabra"**.

- (a) The bid must be accompanied by Earnest Money Deposit amounting to Rs. 22, 05, 679/- in the form of DD/BC in favour of Sr. Accounts Officer (TD), RVUN, Jaipur.
- (b) The tender document cost amounting to Rs. 5,000/- + 18% GST is to be paid in the form of banker's cheque / DD of Nationalized/ Scheduled Bank in favour of Sr. Accounts Officer (TD), RVUN, Jaipur.
- (c) The processing fee of Rs. 1000/- + 18% GST shall be paid in the form of DD/ Banker's cheque in the name of Managing Director, RISL payable at Jaipur.
- (d) The Bidder should upload scanned copy of DD/BC of Earnest Money, tender fee and processing fee on e-procurement website. However, sealed envelopes (Bearing the specific identification of the bidding process pursuant to Notice Inviting bids and any additional identification marks as specified in the bidding) containing the original DD/BC for Tender fee, Processing fee and Earnest Money (EMD) or Declaration for Bid Security/ other document if applicable as per RTPP Act 2012 & Rules 2013 shall be reached/deposited in the office of Superintending Engineer (TD-III), RVUN, Jaipur up to prescribed time & date.

### 3. **PRE-QUALIFYING REQUIREMENT(PQR)**

- (i). Average Annual Turnover (AAT): Average annual turnover of the participating bidder during preceding three (03) financial years as on the date of bid opening should not be less than Rs. 11.02 Crs. Other income shall not be considered for arriving at annual turnover.

**Note:** In case where audited results for the preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.

- (ii). The Bidder should have an experience of having successfully executed /completed either of the following contract for the work of "Operation & Maintenance/ Overhauling of Automated PLC based Coal Handling Plant" having wagon tippler and Stacker-Reclaimer in thermal power plants of unit size 195 MW or above of Govt./Semi Govt./PSU/reputed private sector plant during last 7 years ending last day of the month previous to the date of issue of the NIT. The contract should also include the work of Rail Track Maintenance including Maintenance of marshalling yard, unloading of coal rakes, Operation & Maintenance of Heavy Machinery such as Locomotives, Bulldozers, Loader, Excavator and weighbridges etc. Also bidder should have an experience of handling minimum 350 labours at a time for continuous period of one year in thermal power plants of unit size 195 MW or above of Govt./Semi Govt./PSU/reputed private sector plant during last 07 years ending last day of the month previous to the date of issue of the NIT.

(a) Three contract of "similar works" each costing not less than Rs.4.41 Crs.

OR

(b) Two contract of "similar works" each costing not less than Rs. 5.51 Crs.

OR

(c) One contract of "similar works" costing not less than Rs. 8.86 Crs.

**Similar Work" means:** "Operation & Maintenance /Overhauling of Automated PLC based Coal Handling Plant" having wagon tippler and Stacker-Reclaimer in thermal power plant of unit size 195 MW or above and also handling minimum 350 labours at a time for continuous period of one year in power plants of Govt./Semi Govt./PSU/ reputed private sector power plants. The work should also include Rail Track Maintenance including Maintenance of marshalling yard, unloading of coal rakes, Operation & Maintenance of weighbridges, Operation & Maintenance of Heavy Machinery such as Locomotives, Bulldozers, Loaders and Excavator etc.

The same shall be supported by documentary evidence issued by the owner.

#### **NOTE:**

- I) The word executed means that the bidder should have achieved the progress specified in the QR even if the total contract is not completed/closed. Payment receipt document

with reference to WO No. and date or work execution certificate with executed value and referred order no. & date from the Owner to this effect that the job to this extent has been done by the Bidder satisfactorily may also be considered as a proof of execution even if the work has not been completed in totality (subject to furnishing proof of executed value of work in the form of certified copies of RA Bills) or any relevant documents, which is sufficient to prove the works completed or to be completed.

The same shall be supported by documentary evidence issued by the owner.

The above orders should be directly placed on the tenderer. Experience of Sub-letted work will not be considered.

- (iii). The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour licence and class "A" electrical licence. If any of the above presently is not available with them, then they will furnish an undertaking on Rs. 100/- Non judicial stamp paper duly attested by notary for submitting the same within one month from issue of LOI.

**NOTE:-**

- I) Any firm who have been directly or indirectly terminated/blacklisted in any thermal power plant across India for any reason whatsoever and duration is still continued will not be considered eligible for participation in this tender for which an under taking on Rs. 10/- Non judicial Stamp paper shall be furnished by the bidder. In case if it is found at any point of time that the undertaking given by them is not correct, in that case he will not be considered qualified or order awarded to them shall be terminated. The bidder shall also be black listed for all future contract of RVUN.
- II) Bidder shall produce all supporting documents (original / self-authenticated and attested by Public Notary) in respect of QR as asked in the NIT and an affidavit in original on a Non-judicial stamp paper of Rs. 10/- regarding genuineness of the declaration/information furnished by them and authenticity of the supporting documents being produced by them, within the same time frame.

**4. Evaluation Criteria:-**

The determination of L-1 Bidder shall be decided as per evaluated lowest cost with applicable taxes & duties and GST.

**5. The bidder shall mention GST registration along-with necessary registration certificate.**

6. The bidder will have to register themselves on website <http://www.eproc.rajasthan.gov.in> for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected out rightly.

**7. The tender shall remain valid for the period of 120 days from the date of opening of technical bid.**

8. If any bidder withdraws his tender prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the RVUN, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of

earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or does not start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money and other action shall be taken as per agreement/terms & conditions of the contract/tender. If there is strong justification of believing that the bidder or his authorized person has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited & legal proceedings shall also be initiated.

9. Conditional tenders shall not be accepted and will be liable to be rejected.
10. The department will not be responsible for any delay on account of late submission of tender due to online submission.

**11. Physical submission of bids is not allowed.**

12. The bidder shall ensure that scanned copy of all the schedules as asked in tender document have been filled up and attached with the bid submitted in electronic format.
13. The acceptance of the tender will rest with the competent authority who does not bind itself to accept the lowest tender, and reserves to itself the authority to reject any or all the tenders received without assigning any reason.
14. Tender fee/processing fee is not refundable in any condition.
15. All other conditions shall be prevailing as detailed out in the departmental tender document (in the respective sections/ volumes).
