Validity of bid shall be in all cases considered from actual date of techno-commercial bid opening.

ELIGIBILITY CRITERIA

1. Bidder should have valid goods and service tax registration number, registration with Employees Provident Fund Organisation, Permanent Account number, Labour license and ESIC registrations.

2. Average annual financial turnover during the last 3 years prior to the techno-commercial bid opening should be at least Rs. 8.29 Crore.
3. Experience of having successfully executed building work with RCC frame structure with Govt./Govt. Undertakings during last 7 years ending last day of the month, previous to the month in which techno-commercial bids are opened as any of the following-
 - (a) Three civil works each costing not less than the amount Rs. 4.15 Crore.
OR
 - (b) Two civil works each costing not less than the amount Rs. 5.18 Crore.
OR
 - (c) One civil work costing not less than the amount Rs. 8.29 Crore.

Bidder should submit all documents related to eligibility criteria otherwise they may be declared disqualified and their price bid shall not be opened.

SUBMITTING BIDS-

For submitting bid for this NIT, Bidder should have a Class-2 Digital Signature Certificate issued by any of agencies authorised by Controller of Certifying Authorities, India (website www.cca.gov.in). Further, to upload bid on E-Procurement Portal of Rajasthan, Bidder should be registered with them. Procedures and help for registering and submitting bids are available on the website www.eproc.rajasthan.gov.in. Bidder is required to submit and/or fill up details as required above and as mentioned in bid documents. Bidder should upload with his digital signature all tender documents like NIB, GCC, Technical specifications, drawings, amendments, corrigendum etc. Also, all other documents required to be uploaded as per tender terms and conditions and pertaining to Bidder should have either Bidder's visible digital signature or scan and upload in required electronic format documents containing physical signature of Bidder. Bids should be digitally signed only by a person duly authorised to do so on behalf of the bidder & scanned copy of authorisation letter is to be submitted with bid.

Bids not submitted in manner described above may be rejected. Conditional tenders may be rejected. Bidding processes shall be remained opened for date and time specified above only, Bidders are advised to submit their bids well in time. Any plea on account of failure to upload bid due to any reason shall not be considered. Any corrigendum, amendments, change in dates mentioned above, date of opening price bid and information of award of contract etc. shall be made available on websites www.eproc.rajasthan.gov.in, <http://sppp.rajasthan.gov.in/> and <http://energy.rajasthan.gov.in/rvunl> under respective Tender ID, Bidder should regularly check website and their email registered with E-Procurement Portal for latest updates. Ignorance to updates upon website will not be considered for any plea of Bidder. Bidders may modify the bid before deadline for submission of bids, no additional charges are applicable for modifying the bid. Tender cost and processing fee shall not be refunded in any case. **Physical submission of bids is not allowed.**

OPENING OF BIDS

Bids shall be opened online by authorised officers. First Cover-1 & Cover-2 shall be opened. Then bids shall be evaluated and scrutinised as per tender requirements and names of bidders qualified for opening of price bids shall be published on E-procurement website. Price Bids of qualified bidders shall then be opened online on a date to be notified later. After opening of Price
