Online tenders are invited by Superintending Engineer (TD-III), Rajasthan Rajya Vidyut Utpadan Nigam Limited, Room No. 308, 3rd Floor, Vidyut Viniyamak Bhawan, Sahakar Marg, Jaipur-302005 for “Loading and transportation of crushed coal in Tippers/dumpers/truck from CTPP, Chhabra stock yard to CSCTPP, Chhabra stock yard and then unloading at coal stockyard of CSCTPP, Chhabra.

- (a) The bid must be accompanied by Earnest Money Deposit amounting to Rs. 14,03,600/- in the form of DD/BC in favour of Sr. Accounts Officer (TD), RVUN, Jaipur.
- (b) The tender document cost amounting to Rs. 5,000/- + 18% GST is to be paid in the form of banker's cheque / DD of Nationalized/ Scheduled Bank in favour of Sr. Accounts Officer (TD), RVUN, Jaipur.
- (c) The processing fee of Rs. 1000/-+ 18% GST shall be paid in the form of DD/ Banker's cheque in the name of Managing Director, RISL payable at Jaipur.
- (d) The Bidder should upload scanned copy of DD/BC of Earnest Money, tender fee and processing fee on e-procurement website. 3. PRE-QUALIFYING REQUIREMENT(PQR)

1. The bidder should have executed the work of loading using mechanical equipment (excavators, pay-loader, tippers etc.) transportation by Road and unloading of bulk raw

material/minerals like Coal /Lignite / Gypsum / gitty/ sand/soil during the preceding 07 years reckoned on date of techno-commercial bid opening The executed value of such work should be as per the following criteria:

- i. Executed value not less than 561.44 lacs in a single contract
OR
 - ii. Executed value not less than 350.9 lacs each in a two contract
OR
 - iii. Executed value not less than 280.7 lacs each in a three contract
- a. The word executed means that the bidder should have achieved the progress specified in the QR even if the total contract is not completed / closed. Payment receipt document with reference to W.O No. and date of work execution certificate with executed value and referred order No. & date from the owner to this effect that the job to this extent has been done by the bidder satisfactorily may also be considered as a proof of execution even if the work has not been completed in totality (subject to furnishing proof of executed value of work in the form of certified copies of RA bills) or any relevant documents which is sufficient to prove the works completed or to be completed.
 - b. The above orders should be directly placed on the bidder. Experience of Sublette work will not be considered.
2. Average Annual Turnover (AAT): Average Annual Turnover of the participating bidder during preceding three (03) financial years as on the date of bid opening should not be less than Rs. **701.8 lacs**.
3. Bidder shall produce all supporting documents (original / self authenticated) in respect of QR as asked in the NIT & an affidavit in original on a Non Judicial stamp paper of Rs. 10.00 or as per stamp duty applicable in GoR, regarding genuineness of the declaration/information furnished by them and authenticity of the supporting documents being produced by them within the same time frame

NOTE:

- a. Other income shall not be considered for arriving at annual turnover.
 - b. In cases where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.
 - c. Notwithstanding anything stated above, the RVUN reserves the right to assess the credibility, capability and capacity to perform the contract should circumstances warrant such an assessment in the overall interest of the RVUNL and Bidder shall furnish all other required documents to RVUNL. RVUNL also reserves the right to seek any additional information from bidder(s).
- d. General Requirements for documents to be submitted by the bidder in support of PQR**
- i. Annual reports/copy of audited P&L accounts/certified copies of P&L account, balance sheets.
 - ii. Copies of Purchase Orders and other relevant documents etc. for proof of execution of Purchase Orders.

4. **The bidder shall mention GST registration along-with necessary registration certificate.**
5. The bidder will have to register themselves on website <http://www.eproc.rajasthan.gov.in> for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected out rightly.
6. The tender shall remain valid for the period of 120 days from the date of opening of technical bid.
7. If any bidder withdraws his tender prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the RVUN, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or does not start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money and other action shall be taken as per agreement/terms & conditions of the contract/tender. If there is strong justification of believing that the bidder or his authorized person has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited & legal proceedings shall also be initiated.
8. Conditional tenders shall not be accepted and will be liable to be rejected.
9. The department will not be responsible for any delay on account of late submission of tender due to online submission.
10. Physical submission of bids is not allowed.
11. The bidder shall ensure that scanned copy of all the schedules as asked in tender document have been filled up and attached with the bid submitted in electronic format.
12. The acceptance of the tender will rest with the competent authority who does not bind itself to accept the lowest tender, and reserves to itself the authority to reject any or all the tenders received without assigning any reason.
13. Tender fee/processing fee is not refundable in any condition.
14. All other conditions shall be prevailing as detailed out in the departmental tender document (in the respective sections/ volumes).
15. In addition to above, bidders are requested to study the provisions of RTPP ACT 2012 and Rules 2013 and also note that Acts, Rules & Notifications issued by Rajasthan Transparency Public Procurement (RTPP) will be applicable for the above tender. Further, if there is any contradiction in the tender document from the same, then the Acts, Rules & Notifications of RTPP Act will prevail.
