### 3. PRE-QUALIFYING REQUIREMENTS

To qualify in this bidding process the bidder should have following minimum qualification requirements. The bidder should submit supporting documents in support of his qualification.

- (i) A firm registered under the Indian Partnership Act, 1932 (9 of 1932) or a company incorporated under the Companies Act, 1956 (1 of 1956) or any other legal entity competent to sue or to be sued or enter into contracts must have minimum one BEE Accredited Energy Auditor (AEA) whose name is included in the list of the accredited energy auditors maintained by the Bureau under regulation 7 of the Bureau of Energy Efficiency (Qualifications for Accredited Energy Auditors and Maintenance of their list) Regulations, 2010 and three Certified Energy Auditors who will conduct the detailed energy auditing work under the trade name of their firm. In case of consortium / Joint Venture of two parties, the lead firm should fulfill all qualifying criteria.”
- (ii) The bidder must have successfully conducted energy audit of minimum 2 (two) units of minimum 210 MW capacity of Thermal Power Plants as per CEA,BEE guide lines .The firm should have adequate expertise of field studies including observations, probing skills, collection and generation of data, depth of technical knowledge and analytical abilities for undertaking verification and check-verification. Experienced and reputed service providers in the field are required to send their detailed particulars of the similar job carried out earlier. The prospective bidders shall produce documentary proofs of their having such experience. The bidder shall also provide valid contact details of their clients to enable RVUN to verify the qualifying requirements of the bidder.
- (iii) The bidder should have a valid registration for GST & PAN No.
- (iv) The average annual turnover of the bidder must be minimum Fifty Lacs in last three consecutive financial years prior to the date of opening of tender. The audited P&L and balance sheets for the above three financial years should be enclosed with the bid or to be certified by the practitioner CA.
- (v) The bidder should have strong team to conduct detailed energy audit and should furnish details of the team in following manner:-

- (a) Team member's expertise in the relevant field of energy audit, data management and record keeping for PAT.
- (b) Track record of the team in carrying out detailed energy audit under PAT scheme.
- (c) Names and track record of senior personnel dedicated to the project, and their working experience in India.
- (d) Team members should either be employees or should be having a long-term contract with the organization.
- (vi) The bidder should submit required EMD along with the bid
- (vii) The bidder who qualifies all the above conditions can bid for one station or more.

### **Instructions to the bidders:**

- (i) The bidders will have to register themselves on website <http://www.eproc.rajasthan.gov.in> for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected out rightly.
- (ii) The tender for supply shall remain valid for the period of 120 days from the date of opening of technical bid.
- (iii) If any bidder withdraws his tender prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the RVUN, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or does not start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money/ security deposit and other action shall be taken as per agreement/terms & conditions of the contract/tender. If there is strong justification of believing that the bidder or his authorized person has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited.
- (iv) All tenders, in which any of the prescribed conditions are not fulfilled or which have been vitiated by errors in calculations, totalling or discrepancies in figures or words or other
