The tenderer shall make specific request for each tender separately or same may be downloaded from portal [sppp.rajasthan.gov.in](http://sppp.rajasthan.gov.in).
- (2) Tender documents will be issued only to prima facie qualifying parties after scrutinizing of documents furnished by intending tenderer along with their request for issue of tender documents. However such issue of tender documents will not automatically construe that bidder is considered qualified. Such qualification will be reviewed at the time of evaluation also.
- (3) The tenders shall be received up to 3.00 PM on due date of opening in the office of the Superintending Engineer (Boiler) and these shall be opened at 3.30 PM on the due date in presence of tenderer or their representatives who may like to be present . If the date of tender opening happens to be a holiday, the tenders will be accepted and opened on next working day.
- (4) Tender without earnest money & also tender fee (in case document is downloaded from SPPP portal) & details super scribed on the envelope or accompanied inadequate amount shall not be entertained and in such cases tender shall be returned to the tenderer without being opened, EMD in form of DD in favour of AO (CSCTPP), RRVUNL, payable at Motipura Chowki/ Chhabra shall be furnished in separate envelope along with tender, EMD shall not be accepted in the form of BG or in any other form.
- (5) This office reserves the right to cancel / reject any or all tenders at the time of evaluation without giving any reasons. Not with standing anything stated above the purchaser reserves the right to assess the bidder's capability and capacity to perform the contract, if circumstances warrant such assessment in the overall interest of RVUN. The decision of purchaser in this regard shall be final.

**Qualifying Requirement**

**TN-SC-166 /2018-19/(Boiler)**

### **Annual contract for "works of radiography and Ultrasonic Flow Detection of High Pressure Welding Joints in Boiler and Turbine Area of Unit #5 of 660 MW, CSCTPP, RVUNL, Chhabra.**

The participating bidders in the tender enquiry should fulfil the following qualifying requirements:-

1. The participating bidder should have valid PF and ESI registration, GST registration with central excise department, PAN No. & Labor license (if required).
2. The bidder should have, at least one year experience during last five (5) years, of "Radiography & ultrasonic flow detection of high pressure welding joints in Boiler and turbine area" work in any thermal power station of :-
  - a. Minimum unit capacity of 110 MW or above and station capacity of 1000 MW or above  
OR
  - b. Sub-Vendor of EPC contractor who have executed similar nature of construction work in minimum unit Capacity of 500 MW or above

#### **With contract value as**

- a. Three executed/completed contracts, as above costing not less than the amount equal to 40% of the estimated cost each.  
OR
  - b. Two executed /completed contracts, as above, costing not less than the amount equal to 50% of the estimated cost each.  
OR
  - c. One executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.
3. The bidder should submit the satisfactory work completion/performance certificate in related field duly signed from the competent authority not below the rank of Superintending Engineer or order placing authority of concerned organization.
  4. The average annual turnover of the bidder, in proceeding three(3) financial years ending March shall not be less than 100 % of estimated cost. For this purpose any one of the following documents may be submitted:-
    - (i) Audited balance sheet of last three financial years.
    - (ii) Annual return filed with income tax department.
    - (iii) TDS certificate of last three financial years.
