- (a).The bid must be accompanied by Earnest Money Deposit amounting to Rs. 9,92,000/- is to be paid either through RTGS/NEFT/IMPS/Payorder to SBI Accounts mentioned above or through Demand Draft (DD) in favour of Sr. Accounts Officer (TD), RVUN, Jaipur.
- (b).The tender document cost amounting to Rs. 5,000/- + 18% GST is to be paid either through RTGS/NEFT/IMPS/Pay Order to SBI Accounts mentioned above or through Demand Draft (DD) in favour of Sr. Accounts Officer (TD), RVUN, Jaipur.

### 3. **PRE-QUALIFYING REQUIREMENT(PQR)**

"Bidders who wish to participate in the bidding should meet the following qualifying requirement (PQR) :-

#### **A. Technical Criteria**

- (i). The Bidder should be an Owner/ BTG OEM/ EPC Contractor having successfully executed /completed work of Erection, Testing & commissioning, stabilizing fully Automated DCS Controlled **Supercritical Thermal Power Plant** of unit size 660 MW & above. Total experience of the bidder for power plant operation should not be less than 2 years during last 7 years ending last day of the month previous to the date of issue of the NIT.

Or

- (ii). The Bidder should have executed work of initial unit stabilizing, Operation & Maintenance of fully Automated DCS Controlled **Supercritical Thermal Power Plant** of unit size 500 MW & above. Total experience of the bidder for power plant operation should not be less than 2 years during last 7 years ending last day of the month previous to the date of issue of the NIT.

The power plants for both the categories should be pulverized coal based comprising of SG , STG with associated auxiliaries, and all other unit specific balance of plant system/equipment and should have centralized operation and monitoring of the power plant from the central control room (CCR). The system shall consist of a functionally distributed microprocessor based system (DCS based) operation, control and monitoring.

#### **B. Financial Criteria**

- (iii). For the above second category, the contractor should have carried out work of similar nature with minimum orders of executed values as under :-
- a) Minimum one order of contract value 3.96 crore per annum  
OR  
b) Minimum 2 orders of 2.47 crore each per annum

OR

- c) Minimum 3 orders of 1.98 crore each per annum.
- (iv). Average Annual Turnover of such contractors for both the categories should not be less than Rs. 4.956 crores per annum during last 3 financial years.

**NOTE 1:** The word "executed" means the bidder should have achieved the criterion specified in QR, even if the total contract is not completed/closed. Payment receipt document with reference to WO No. and date or work execution certificate with executed value and referred order no. & date from the Owner to this effect that the job to this extent has been done by the Bidder satisfactorily may also be considered as a proof of execution even if the work has not been completed in totality (subject to furnishing proof of executed value of work in the form of certified copies of RA Bills) or any relevant documents, which is sufficient to prove the works completed or to be completed. The same shall be supported by documentary evidence issued by the owner.

**NOTE 2:**

- I) In case where audited results (Balance Sheets and Profit & Loss Statement) for the preceding three (03) financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.
- II) The above orders should be directly placed on the tenderer. Experience of Sub-letted work will not be considered.
- III) The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour licence and class "A" electrical license. If any of the above presently is not available with them, then they will have to furnish an undertaking to the effect that same shall be furnished within one month from issue of LOI.

**4. Evaluation Criteria:-**

The L-1 Bidder shall be evaluated / decided on the basis of lowest quoted price inclusive of all taxes & duties except GST.

**5. The bidder shall mention GST registration along-with necessary registration certificate.**

6. The bidder will have to register themselves on website <http://www.eproc.rajasthan.gov.in> for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected out rightly.

**7. The tender shall remain valid for the period of 120 days from the date of opening of technical bid.**

8. If any bidder withdraws his tender prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the RVUN, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or does not start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money and other action shall be taken as per agreement/terms & conditions of the contract/tender. If there is strong justification of believing that the bidder or his authorized person has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited & legal proceedings shall also be initiated.
9. Conditional tenders shall not be accepted and will be liable to be rejected.
10. The department will not be responsible for any delay on account of late submission of tender due to online submission.
- 11. Physical submission of bids is not allowed.**
12. The bidder shall ensure that scanned copy of all the schedules as asked in tender document have been filled up and attached with the bid submitted in electronic format.
13. The acceptance of the tender will rest with the competent authority who does not bind itself to accept the lowest tender, and reserves to itself the authority to reject any or all the tenders received without assigning any reason.
14. Tender fee/processing fee is not refundable in any condition.
15. All other conditions shall be prevailing as detailed out in the departmental tender document (in the respective sections/ volumes).
