- (a).The bid must be accompanied by Earnest Money Deposit amounting to Rs. 11,61,577/- is to be paid either through RTGS/NEFT/IMPS/Payorder to SBI Accounts mentioned above or through Demand Draft (DD) in favour of Sr. Accounts Officer (TD), RVUN, Jaipur.
- (b).The tender document cost amounting to Rs. 5,000/- + 18% GST is to be paid either through RTGS/NEFT/IMPS/Pay Order to SBI Accounts mentioned above or through Demand Draft (DD) in favour of Sr. Accounts Officer (TD), RVUN, Jaipur.
- (c).The processing fee of Rs. 1000/- + 18% GST shall be paid in the form of DD in the name of Managing Director, RISL payable at Jaipur.

### 3. **PRE-QUALIFYING REQUIREMENT(PQR)**

"Bidders who wish to participate in the bidding shall satisfactorily establish to fulfill following qualifying requirement:-

(i). **Financial QR:-**

Average Annual Turnover (AAT) of the participating bidder during preceding three (03) financial years as on the date of techno-commercial bid opening, shall not be less than Rs. 5.80 Crores(Rs. Five Crores Eighty Lacs Only). Other income shall not be considered for arriving at annual turnover.

**Note:-**Bidder shall submit/furnish duly certified audited balance sheet and profit & loss account statement/Annual report or duly certified certificate from practicing CA showing the details of Average Annual Turnover of preceding three (03) financial years as on the date of techno-commercial bid opening, to adjudge Average Annual Turnover criteria.

(ii). **Technical QR:-**

The bidder should have executed the similar work in India during the preceding seven (07) years reckoned as on the date of techno commercial bid opening having:

- Executed value not less than **Rs. 4.64 Crores** in a Single Contract.  
OR
- Executed value not less than **Rs. 2.90 Crores** in Two Contracts each.  
OR
- Executed value not less than **Rs. 2.32 Crores** in Three Contracts each.

**Similar works means either of the following:**

**(a)** The bidder must have executed Complete maintenance Contract (Boiler, Turbine and Generator) of 660 MW station or above capacity for a period of One(01) years or more in a single contract or repeat contract in the preceding seven (07) years reckoned as on the date of techno-commercial bid opening. Repeat contract means even if original contract was awarded for smaller duration, if the same contract period is extended, the total duration shall include extended duration in addition to original contract duration for the purpose of evaluation.

**OR**

**(b)** The bidder must have executed minimum two numbers Turbine overhauls {(High Pressure (HP) Turbine, Intermediate Pressure (IP) Turbine, Low Pressure (LP) Turbine}, Generator and Valves together or in split contracts, minimum two nos. Boiler overhauls of 250 MW or above capacity power plants in last seven (07) years reckoned as on the date of techno-commercial bid opening. For the purpose of evaluation, One overhaul of

Turbine, Generator & its auxiliaries and one overhaul of Boiler and its auxiliaries put together and executed in any consecutive 12 months period shall be treated as One Contract even if these are executed as separate contracts.

**OR**

- (c) The bidder must have executed erection and commissioning of at least One unit (Boiler and Turbine and Generator) of 500MW or above in last 7 years in combined or separate contracts reckoned as on the date of techno-commercial bid opening. One unit comprises of Boiler and Turbine (HP, IP & LP) and Generator required for 500 MW (or more) unit capacity.

**OR**

- (d) OEM/OES of SG & its Auxiliaries Packages and TG & its Auxiliaries Package for Chhabra Supercritical Thermal Power Project (CSCTPP), Chhabra & Suratgarh Supercritical Thermal Power Project (SSCTPP), Suratgarh i.e. M/s L&T Limited, M/s BHEL shall be deemed /considered to have met Technical Criteria stipulated in qualifying Requirements of this work. However, in case they bid for the Tender, they shall have to qualify Financial Criteria stipulated in this Qualifying Requirements.

**NOTE 1:**

The word "executed" means the bidder should have achieved the criterion specified in QR, even if the total contract is not completed/closed. Payment receipt document with reference to WO No. and date or work execution certificate with executed value and referred order no. & date from the Owner to this effect that the job to this extent has been done by the Bidder satisfactorily may also be considered as a proof of execution even if the work has not been completed in totality (subject to furnishing proof of executed value of work in the form of certified copies of RA Bills) or any relevant documents, which is sufficient to prove the works completed or to be completed. The same shall be supported by documentary evidence issued by the owner.

**NOTE 2:**

- I) In case where audited results (Balance Sheets and Profit & Loss Statement) for the preceding three (03) financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.
- II) The above orders should be directly placed on the tenderer. Experience of Sub-letted work will not be considered.
- III) The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour licence and class "A" electrical licence. If any of the above presently is not available with them, then they will have to furnish an undertaking to the effect that same shall be furnished within one month from issue of LOI.

**4. Evaluation Criteria:-**

The determination of L-1 Bidder shall be decided as per evaluated lowest cost with loading of applicable GST.

**5. The bidder shall mention GST registration along-with necessary registration certificate.**

6. The bidder will have to register themselves on website <http://www.eproc.rajasthan.gov.in> for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected out rightly.
- 7. The tender shall remain valid for the period of 120 days from the date of opening of technical bid.**
8. If any bidder withdraws his tender prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the RVUN, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or does not start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money and other action shall be taken as per agreement/terms & conditions of the contract/tender. If there is strong justification of believing that the bidder or his authorized person has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited & legal proceedings shall also be initiated.
9. Conditional tenders shall not be accepted and will be liable to be rejected.
10. The department will not be responsible for any delay on account of late submission of tender due to online submission.
- 11. Physical submission of bids is not allowed.**
12. The bidder shall ensure that scanned copy of all the schedules as asked in tender document have been filled up and attached with the bid submitted in electronic format.
13. The acceptance of the tender will rest with the competent authority who does not bind itself to accept the lowest tender, and reserves to itself the authority to reject any or all the tenders received without assigning any reason.
14. Tender fee/processing fee is not refundable in any condition.
15. All other conditions shall be prevailing as detailed out in the departmental tender document (in the respective sections/ volumes).
