### ORDER

#### Sub: Rajasthan Civil Services (Revised Pay) Rules, 2017.

Pursuant to approval of the Finance Department, Government of Rajasthan, conveyed by the Energy Department, Government of Rajasthan vide letter No.F.4(43)Energy/2017 dated 8.6.2018, the Chairman & Managing Director in consultation with Director (Finance) has decided to make following amendment in Rajasthan Civil Services (Revised Pay) Rules, 2017 :-

- (i) a new pay level – “L-10A” shall be inserted at S.No.-10A in Schedule-I (Part-A) of GoR’s Notification No. F.15(1)FD/Rules/2017 dated 30.10.2017 appended with Nigam’s order No.RVUN/P&A/F.7<sup>th</sup>PC/D.324 dated 1.1.2018 (P&A-276), as follows :-


