ORDER

In light of recommendations of the Coordination Committee in its 10th meeting held on 14th & 15th March, 2018 it has been decided to adopt the notifications no. F.7(2)DOP/A-II/84 Pt. dated 6.3.2018 and no. F.1(5)FD/Rules/2016 dated 13.3.2018 issued by the Government of Rajasthan for enhancing the maximum age limit for appointment in various services.

Accordingly, the existing expression “**31 years**” or “**35 years**”, as the case may be, occurring in the regulation as mentioned in column number 3, against each of the service regulations as mentioned in column number 2 of the following table, shall be substituted by the expression “**40 years**” :-
