ORDER

Sub: Amendment in the RVUN Services (Absorption of Ex-Servicemen) Regulations, 2017.

Chairman & Managing Director in consultation with Director (Finance) has decided to adopt, mutatis mutandis, the notification no.F.5(18)DOP/A II/84 pt-II dated 17.04.2018, issued by the Government of Rajasthan. Accordingly, following amendments are hereby made; namely :-

I. The existing regulation 2 shall be substituted by the following:-

“2. Reservation of posts for the ex-servicemen -

(1) Notwithstanding the provisions contained in any regulation, regulating the recruitment to any post, reservation of posts for the ex-servicemen in Nigam, to be filled in by direct recruitment, shall be as under –

(a) 5% of the posts covered under the Officers' Service Regulations, 2017 and the Engineers' Service Regulations, 2016 (excluding the posts of Junior Engineer, Junior Chemist and Informatics Assistant).

(b) 12½ % of the posts of Junior Engineer, Junior Chemist and Informatics Assistant as well as all posts covered under the Ministerial Staff Service Regulations, 2017 and Technical Workmen Service Regulations, 1975; and

(c) 15% of the posts in Class-IV service;

or

such percentage of posts as reserved under relevant service regulations, whichever is higher.

(2) Maximum number of such ex-servicemen in a particular cadre shall also be limited to the percentage as specified in sub-regulation (1) above.

(3) The reservation for ex-servicemen shall be treated as horizontal reservation and it shall be adjusted in the respective category to which the ex-servicemen belong.

(4) Where a vacancy reserved for ex-servicemen under these regulations, remains unfilled due to non-availability of suitable ex-servicemen in a particular year, the vacancies so reserved for them shall be filled in accordance with the normal procedure and equal number of vacancies shall be carried forward to the next recruitment year and thereafter such vacancies would lapse."

II. Following shall be added in regulation 3:-

- (i) at the end of sub-clause (iii) of clause (iv) of sub-regulation (a), the expression "or" shall be added ;
- (ii) after the existing clause (iv) of sub-regulation (a), so amended, the following new clause (v) shall be added, namely:-

"(v) Ex-recruits boarded out or released on medical grounds and granted medical/ disability pension."

(iii) the existing sub-regulation (g) shall be deleted; and

III. In existing regulation 5 of the said regulations, for the existing expression "the post specified in Schedule-I," shall be substituted by the expression "*the posts specified in the relevant service regulations,*".

IV. The existing regulation 6 of the said regulations shall be deleted.

V. After the existing regulation 7, following new regulation 7A shall be inserted, namely:-

7A. Submission of proof of Retirement - A person who has retired or is retiring within forthcoming one year, after earning his/ her pension on the basis of no-objection certificate (NOC) from the competent authority, shall be eligible to apply for the post but he/ she shall have to submit proof of retirement to the appropriate selection agency/committee,-

- (a) before appearing in the main examination, where selection is made through two stages of written examination and interview;
- (b) before appearing in examination where selection is made through written examination and interview;
- (c) before appearing in written examination or interview where selection is made through only written examination or only interview, as the case may be."

VI. The existing regulations 9 to 16 of the said regulations shall be deleted.

VII. After the regulation 16 so deleted and before the PART-III of the said regulations, the following new regulations 16A and 16B shall be inserted; namely :-

②

“16A. Concessions - Following concessions shall be allowed to the ex-servicemen for making them eligible for employment:-

- (i) if minimum qualifying of pass marks in individual paper and/or in aggregate marks, wherever prescribed to qualify the competitive examination for any post, relaxation of five percent or as prescribed in relevant service regulations, whichever is higher, shall be given to the ex-servicemen;
- (ii) relaxation in upper age limit shall be –
 - (a) for posts covered under the Officers’ Service Regulations, 2017 and the Engineers’ Service Regulations, 2016 (excluding the posts of Junior Engineer, Junior Chemist and Informatics Assistant) - **five years**,
 - (b) for the posts of Junior Engineer, Junior Chemist and Informatics Assistant – **fifteen years**,
 - (c) for all other services or posts – equal to the length of military service increased by **three years**;

Provided that permissible age after relaxation work out to be more than 50 years then upper age limit of 50 years will be applicable; and

- (iii) physical fitness or physical test parameters wherever prescribed for selection to any post such parameters shall be relaxed appropriately by the Nigam.


“16B. Application of provision of the relevant service regulations - Except otherwise provided in these regulations all other provisions of regulations regulating the recruitment of the post concerned shall apply to the recruitment and appointment to the post reserved under these regulations.”

VIII. The existing regulations 17 to 19 of the said regulations shall be deleted.

IX. The existing Schedule-I of the said regulations shall be deleted.

This is subject to ratification by the Board of Directors.


